RESOLUTION OF THE BOARD OF SUPERVISORS COUNTY OF HUMBOLDT WHEREAS, the Humboldt County Library Construction Advisory Committee worked persistently for 22 years from concept to completion to build the combined Humboldt County Library headquarters and the Eureka Main Library at 1313 Third Street, Eureka; and WHEREAS, the Eureka Main Library had its grand opening on November 4, 1995 and represents the collective effort of hundreds of volunteers and thousands of contributors who worked against many obstacles to realize the construction of this 64,000 square-foot public library to benefit all of the citizens of Humboldt County; and WHEREAS, during the month of November 2015, the people of Humboldt County will celebrate the 20th anniversary of the opening of the Eureka Main Library, and in recognition of this historic occasion, the community is deserving of special publiccommendations from the Board of Supervisors; and WHEREAS, historically, in 1859, the Eureka Library Association established a public library in Eureka, and in 1915, the Humboldt County Board of Supervisors established the Humboldt County Free Library to serve county residents which was housed in various locations, and in 1960, it was moved temporarily to the Humboldt County Courthouse. In 1972, the City of Eureka Public Library and the Humboldt County Library combined their institutions; and WHEREAS, in 1973, a Library Construction Advisory Committee was appointed to plan for a new combined Humboldt County Library headquarters and Eureka Public Library structure for which architectural planning began and a major fundraising campaign launched in 1985; and WHEREAS, in 1988, California's 2nd District State Senator Barry Keene sponsored the Construction and Renovation Bond Act which was passed successfully by California voters, and approved a \$75 million dollar bond act for library construction statewide, and between the years 1988 to 1991, the Library Construction Advisory Committee and the Friends of the Redwood Libraries raised over \$1.5 million dollars in local funds to match state grant funds; and WHEREAS, in 1989, the Humboldt County Board of Supervisors pledged funds to meet the local match requirement of the Library Construction and Renovation Bond Act; and WHEREAS, in 1991, out of the 110 statewide applications received for funds, Humboldt County successfully secured one of 16 grant applications that were awarded that year, and received 65 percent of the project funds necessary to construct the new Eureka Main Library; and WHEREAS, in September 1993, ground breaking ceremonies were held for the Eureka MainLibrary at its current location, and the Library Construction Advisory Committee demonstrated to all Californians their dedication, perseverance and commitment to the greater good of the community. NOW, THEREFORE, BE IT RESOLVED, that the Humboldt County Board of Supervisors hereby commends the hard work and public spirit demonstrated by everyone involved in the planning, development and completion of the new Eureka Main Library, and urges the public to participate in the 20th Anniversary celebration and ceremonies of the Eureka Main Library Estelle Fennell Chair October 27, 2015 민민민민민민
