A motion was made by Supervisor Bohn, seconded by Supervisor Bushnell to approve the following: Use of remaining American Rescue Plan Act (ARPA) funds to reduce the use of General Fund; Keep Local Assistance and Tribal Consistency Funds (LATCF) unallocated; Deallocate 1.0 Correctional Deputy in the Sheriff's Office; Approve the parameters of the Volunteer Separation Incentive Program (VSIP); Continue to explore Mandatory Furloughs while including a consideration for a flexible week long furlough and a furlough day once every other week; Reduce funding to the District Attorney Measure Z budget to deallocate one vacant IT Technician position (\$82,101); Deallocate 1.0 FTE IT Technician I/II Measure Z position to the District Attorney's office; and allocate \$320,000 to K'ima:w Medical Center, \$120,000 to Southern Trinity Area Rescue (\$TAR), \$195,438 to the City of Fortuna Police Department for the county-wide Drug Task Force, and the remaining (approximately \$500,000) to the Humboldt County Fire Chief's Association.
