**PROCLAMATION  
OF THE  
BOARD OF SUPERVISORS  
COUNTY OF HUMBOLDT**

**DECLARING THE MONTH OF APRIL  
FAIR HOUSING MONTH IN THE COUNTY OF HUMBOLDT**

**WHEREAS**, the County of Humboldt is joining with the United States Department of Housing and Urban Development (HUD) and other housing agencies in celebrating the anniversary of the National Fair Housing Law, Title VII of the Civil Rights Act of 1968; and

**WHEREAS**, the County of Humboldt encourages fair housing through sales and rentals, as well as through its housing rehabilitation and first time homebuyer programs; and

**WHEREAS**, discrimination in housing is against the law. No person shall be discriminated against because of age, race, color, creed, religion, ancestry, national origin, sex, sexual preference, disability, marital/familial status, income source, status with regard to public assistance, or any other arbitrary factor in the sale, rental, or advertising of dwellings, in the provisions of brokerages services, or in the availability of residential real estate related transactions; and


**WHEREAS**, if any County resident believes he or she has been discriminated against, the resident should contact Legal Services of Northern California. They will provide information, counseling, and referral to the appropriate agency if a formal complaint needs to be filed; and

**WHEREAS**, in addition to the County's efforts, information is also available at the Eureka-Humboldt Housing Authority. The Legal Services of Northern California and the Eureka-Humboldt Housing Authority offices help to ensure that all residents of Humboldt County are treated fairly and that all the property owners and landlords abide by the letter and spirit of the Fair Housing Law; and

**WHEREAS**, the County of Humboldt, the State of California, HUD and various local agencies are working together to ensure equal treatment of all citizens. We urge everyone to practice the Fair Housing Law; and

**NOW, THEREFORE, BE IT RESOLVED**, that the Humboldt County Board of Supervisors hereby declares the month of April, 2017 as Fair Housing Month in Humboldt County.
