Subject: Comments on the Draft Inland & Coastal Lighting Ordinances

Thank you for this opportunity to comment on the draft Inland and Coastal Lighting Ordinances, which we submit on behalf of Humboldt Waterkeeper. Humboldt Waterkeeper works to safeguard coastal resources for the health, enjoyment, and economic strength of the Humboldt Bay community through education, scientific research, and enforcement of laws to fight pollution.

We are grateful to staff for adding our requested illumination maximums, and for researching commercially available lightbulbs, in order to adjust this maximum to allow for the most commonly available bulbs. We support the new 1100 lumen and 3200 lumen limits for residential and commercial properties, to this end.

To align with Humboldt County's General Plan, Chapter 5, IS-P20, IS-S9, and IS-IM17, please include streetlighting in this ordinance.

In section 10.1.2.2.1 both ordinances state that "Light fixtures that use translucent material to cover the light source may be acceptable if the bulbs have a correlated color temperature (CCT) of 2700 K or less in lieu of being fully shielded." Translucent shielding material essentially defeats the purpose of shielding, by allowing some light to escape upwards or sideways, which is in direct conflict with the definition of "fully shielded" in this ordinance. The allowance for 'translucent material' caveat should be removed from this section. In the unfortunate case this 'translucent material' caveat remains, we request additional language prescribing intensity limits as defined in 105.1.5.1 and 105.1.6.1

The exemptions outlined in section 105.1.4 provide nearly wholesale exemptions for a wide variety of light sources that cause not only light trespass, but light pollution. We suggest adding language to clarify which requirements each lighting type is still subject to or exempt from. Additionally, the following exemptions could go further to prevent light pollution:

- 105.1.4.2 (flags, statues, other objects): This exemption could be refined to ensure that lighting for flags, statues, and other objects does not obscure the night sky, by adding language requiring the lights to be turned off after a certain time, such as an hour after sunset.
- 105.1.4.4 "Athletic field lighting used within a school campus or public or private park":
 Rather than exempting athletic field lighting entirely, we recommend outlining specific
 limits by adding an athletic field section. Dark Sky International recommends sport
 lighting to never exceed a CCT of 5700 K, and the luminous intensity not to exceed
 10,000 candelas as measured along a perimeter that is 150 feet from the edge of the
 field, at 5 feet above grade (see Dark Sky International's Municipal Code Template,
 Section 2.4 Sports Lighting, page 6-7).
- 105.1.4.3 String lights with a CCT of 2700 K or less: Color temperature is not the same
 as light intensity—string lights that are warm can still cause light pollution. Thus, to
 minimize light pollution, we suggest adding language requiring string lights to be turned
 off after a certain hour if not being used for demonstrable safety purposes (timers are
 commercially and readily available, which could be used for this purpose).
- 105.1.4.5 Emergency lighting: This exemption is vague, and would benefit from parameters defining what qualifies as an emergency.
- 105.1.4.6 "Motion detector lighting fixtures": Motion detectors on lighting fixtures are an excellent tool to ensure lights are not left on unnecessarily, especially after sunset. Here, they are used to exempt lighting from all of the requirements of the ordinance. Instead, we recommend removing motion detector lighting fixtures from the exemption section, and instead list them as tools to reduce light pollution in combination with timers for streetlights, commercial lights, and residential lights. Motion detector light fixtures can be set to dim, instead of turning off the light completely, if there are safety concerns.

Thank you for this opportunity to shape the County's lighting ordinance, we are excited to see the County tackle light pollution.

I highly value stargazing and experiencing the natural world at night with all the wildlife coming and going. This is boots-to-pavement work — done by neighbors, for neighbors. With your backing, we can continue to **not just meet state environmental standards, but help define them**.



I would like to submit a comment on the above referenced subject. I urge the Board of Supervisors to pass the draft ordinance passed by the Humboldt County Planning Commission with the following additions:

- · Include street lighting in the ordinance, in line with the County's General Plan guidance.
- · The requirement for fully shielded lighting includes a caveat for translucent shielding material. This defeats the purpose of shielding, by allowing some light to escape upwards or sideways—in direct conflict with the definition of "fully shielded" in these ordinances.
- Eliminate exemptions for lights with motion detectors, which should just be another tool to protect the night sky alongside shielding, warm temperatures and lower intensity bulbs.
- · Eliminate intensity and color temperature exemptions for string lighting, and require them to be on timers.


Protection of the night skies by lowering the amount of light is critical for migrating birds and other wildlife particularly in coastal zones, rivers, estuaries, and nearshore areas. Additionally, the increasing amount of night light pollution around our planet is a disrupts the circadian rhythms of people, and disconnects humans from our natural circadian rhythms, pushing us to exercise, eat, or sleep at random, contributing to insomnia, depression, obesity, and loss of night vision. Night light pollution also affects plant physiology by altering growth and timing of flowering which affects migratory patterns of pollinators and seed-dispersers that rely on nectar, pollen, seeds, and fruits for food.

Our County can take the lead in mitigating these harmful effects of night sky pollution to help maintain our resources.



Dear Sirs & Madams: I urgently entreat you to adopt a strict outdoor lighting ordinance. We must protect our night skies while we still can. There is absolutely no reason to require street lights everywhere in rural area.
