WHEREAS, in compliance with Government Code section 7522.56 the Humboldt County

Board of Supervisors must provide California Public Employees Retirement System (CalPERS) this certification resolution when hiring a retiree before 180 days has passed since his retirement; and

**WHEREAS**, Robert Nickell retired from the Humboldt County Agricultural Commissioner's Office in the position as Senior Agricultural/Weights and Measures Inspector, effective September 3, 2021; and

**WHEREAS**, Section 7522.56 requires that post-retirement employment commence no earlier than 180 days after the retirement date, which is March 2, 2022, without this certification resolution; and

**WHEREAS**, Section 7522.56 provides that this exception to the 180-day wait period shall not apply if the retiree accepts any retirement-related incentive; and

**WHEREAS**, the Humboldt County Board of Supervisors, the Humboldt County Agricultural Commissioner's Office and Robert Nickell certify that Robert Nickell has not and will not receive a Golden Handshake or any other retirement-related incentive; and

**WHEREAS**, the Humboldt County Board of Supervisors hereby appoints Robert Nickell as an extra help retired annuitant to perform the duties of the Senior Agricultural/Weights and Measures Inspector for the Agricultural Commissioner's Office under Government Code section 21224, effective October 5, 2021; and

**WHEREAS**, the entire employment agreement, contract or appointment document between Robert Nickell and the Agricultural Commissioner's Office has been reviewed by this body and is included herein; and

**WHEREAS**, no matters, issues, terms or conditions related to this employment appointment have been or will be placed on a consent calendar; and

WHEREAS, the employment shall be limited to 960 hours per fiscal year; and

**WHEREAS**, the compensation paid to retirees cannot be less than the minimum nor exceed the maximum monthly base salary paid to other employees performing comparable duties, divided by 173.333 to equal an hourly rate; and

**WHEREAS**, the maximum base monthly salary for this position is \$5,562.62 and the hourly equivalent is \$32.09, and the minimum base monthly salary for this position is \$4,334.87 and the hourly equivalent is \$25.01; and

WHEREAS, the hourly rate paid to Robert Nickell will be \$32.09; and

**WHEREAS**, Robert Nickell has not and will not receive any other benefit, incentive, compensation in lieu of benefit or other form of compensation in addition to this hourly pay rate.

NOW, THEREFORE, BE IT RESOLVED that the Humboldt County Board of Supervisors hereby certifies the nature of the appointment of Robert Nickell as described herein and detailed in the attached agenda item titled "Temporary Employment of Retired Annuitant as Senior Agricultural/Weights and Measures Inspector for the Agricultural Commissioner's Office", is necessary to fill the critically needed position of Senior Agricultural/Weights and Measures Inspector for the Agricultural Commissioner's Office by October 5, 2021 because Robert Nickell has unique knowledge and skills related to the Commissioner/Sealer's Office and will be able to perform large commercial device inspections and provide training to staff.
