WHEREAS, closing the Digital Divide is vital to the economic prosperity and quality of life for residents in Humboldt County and throughout California; and

WHEREAS, Humboldt County finds and declares that high-speed Internet access – referred to generically as "broadband" and including both wireline and wireless technologies – is essential 21st Century infrastructure in a digital world and global economy; and

WHEREAS, Humboldt County is committed to identifying strategic actions that will remove barriers to and promote the deployment and adoption of broadband among residents, customers, and recipients of public services; and

WHEREAS, the Redwood Coast Connect is Humboldt County's designated broadband consortium pursuant to the CASF Consortia Grant program; and

WHEREAS, the Consortia Grant program urges two Supervisors to be designated as liaisons.

NOW, THEREFORE, BE IT RESOLVED that the Humboldt County Board of Supervisors:

- 1. Hereby, supports the Redwood Coast Connect Rural Consortium's submission to the California Advance Services Fund on behalf of the region.
- 2. Hereby, appoints Supervisor Rex Bonn and Ryan Sundberg as the Humboldt County Board of Supervisors representatives in the Redwood Coast Connect Consortium.
