- 1. Adopt the Project Coordinator I/II classification in the AFSCME Bargaining Unit (classification # 0254A/B, salary range 421/445) into the classification system effective the pay period following board approval;
- 2. Adopt the Compensation Schedule effective May 11, 2025;
