**RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS IMPLEMENTING PHASE 2 EQUITY INCREASES FOR CERTAIN CLASSIFICATIONS IN HUMBOLDT DEPUTY SHERIFFS' ORGANIZATION REPRESENTATION UNIT 6 AND ADOPTING THE COMPREHENSIVE COMPENSATION SCHEDULE**

**WHEREAS**, the Board of Supervisors of the County of Humboldt (County) is authorized by the provisions of Section 25300 of the Government Code of the State of California to provide for the number, compensation, tenure, appointment and conditions of employment of County employees by resolution; and

**WHEREAS**, on December 14, 2021, the Board of Supervisors adopted Resolution No. 21-1825, providing for the implementation of the 2021-2024 Memorandum of Understanding for the Humboldt Deputy Sheriff's Organization for Representation Unit 6; and

**WHEREAS**, the Board of Supervisors intends to amend the 2021-2024 Memorandum of Understanding for the Humboldt Deputy Sheriff's Organization for Representation Unit 6; and

**WHEREAS**, California Employees Retirement System (CalPERS) requires all government agencies to provide and make available to the public the salary of all full-time, part-time employees and Elected Officials in a single salary format specified by CalPERS.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS:**

1. Approve the implementation of the Phase 2 equity increases effective the pay period following board approval, by assigning the following classifications to the following salary ranges:
  - Senior Welfare Investigator (class # 0741) from salary range 487 to 498
  - Welfare Investigator Supervisor (class # 0740) from salary range 497 to 518
2. Approve the removal of the following unused 37.5-hour classifications from the classification system effective the pay period following board approval:
  - Probation Officer I/II (class # 0472A/B)
  - Senior Probation Officer (class # 0471)
3. Approve the Comprehensive Compensation Schedule and Classification Summary effective the pay period following board approval (Attachment 5).
