PROCLAMATION of the Board of Supervisors County of Humboldt

"International Overdose Awareness Day" August 31, 2017

WHEREAS, addiction is a disease and the stigma associated with addiction must be addressed so that no one feels shame or disgrace over a drug overdose; and

WHEREAS, the theme for 2017 International Overdose Awareness Day is "Time to Remember, Time to Act"; and

WHEREAS, by acknowledging all those who have been affected by overdose, we help the general public understand its effects on Humboldt County Communities: and

WHEREAS, in the United States 43,982 people die each year, an average of 120 deaths per day; and

WHEREAS, Overdose Awareness Day acknowledges that overdose deaths devastate families, friends and communities. This day recognizes overdoses from all drugs allowing us to speak and educate more broadly about the issues while making a commitment to preventing future deaths; and

WHEREAS, Overdose Awareness Day sends a strong message to individuals who formerly used or currently use substances that they are valued.

NOW THEREFORE, BE IT RESOLVED, that the Humboldt County Board of Supervisors hereby proclaims August 31, 2017 as International Overdose Awareness Day in Humboldt County to bring awareness to the very important issue.
