# PROCLAMATION OF THE BOARD OF SUPERVISORS COUNTY OF HUMBOLDT

WHEREAS, Kiwanis International was founded on January 21, 1915 and is celebrating its 100<sup>th</sup> Anniversary this month; and

WHEREAS, the six objects of Kiwanis International are:

- \*To give primacy to the human and spiritual rather than to the material values of life.*
- \*To encourage the daily living of the Golden Rule in all human relationships.*
- \*To promote the adoption and the application of higher social, business, and professional standards.*
- \*To develop, by precept and example, a more intelligent, aggressive, and serviceable citizenship.*
- \*To provide, through Kiwanis clubs, a practical means to form enduring friendships, to render altruistic service, and to build better communities.*
- \*To cooperate in creating and maintaining that sound public opinion and high idealism which make possible the increase of righteousness, justice, patriotism, and goodwill; and*

WHEREAS, the Kiwanis motto is: "Serving the Children of the World" and the Kiwanis defining statement is: "Kiwanis is a global organization of volunteers dedicated to improving the world one child and one community at a time"; and

WHEREAS, the first Kiwanis Club in Humboldt County was formed in 1924 and there are currently nine Kiwanis Clubs in the following areas: Arcata, Eureka (3) - Action Club, North Coast and Henderson Center, Ferndale, Fortuna, McKinleyville, Redwoods (Garberville), Willow Creek; and

WHEREAS, the Kiwanis Clubs in Humboldt County have performed countless hours of community service, improved our area and citizenry, and donated thousands of dollars to our local community; and

WHEREAS, the Kiwanis Clubs engage the youth of our community in service and leadership development through sponsorship of: K-Kids in elementary school, Builders Club in Junior High, Key Club in High School, Circle K at HSU, Future Farmers of America, Boy Scout Troops, and Cub Scout Packs; and

WHEREAS, the Board of Supervisors wishes to acknowledge the enhancements to our community made by the Kiwanis Clubs in Humboldt County.

NOW, THEREFORE, the Humboldt County Board of Supervisors hereby proclaims, January 21, 2015 as Kiwanis Day in Humboldt County.
