Lelehnia DuBois embodies the spirit and culture of Humboldt County. The region has been an incubator for creativity, healing, and diversity since the late 1960s when it attracted a large migration of counter culture. Many came to purchase land and grew cannabis to support a homesteading lifestyle. Because of this crop the communities have been steeped in controversy for the last several decades. It is a community that has overcome much adversity and persevered through extensive periods of persecution and victimization. These trials and tribulations have forged a sense of grace in the region's inhabitants, shaping a vibrant culture which stands up for what it believes in.

Lelehnia Dubois grew up in two worlds. Her father enrolled her in performing arts school, Junior Lifeguards, she shopped at "Nordies", lived the So Cal lifestyle. Her mother had her homesteading and learning the trades of the Northern California mountains. Lelehnia grew up disliking cannabis and its effects. She has witnessed raids, family homelessness, children left in the cold through harsh winters, all results of the drug war. She chose to live a life outside of her northern community, which provided her with a diverse background in retail, hospitality, political, and project management disciplines. Following her mother's death, she moved back to Humboldt Country to care for her two younger sisters, but sustained a spinal injury while working as a nurse, which required her to use many pharmaceuticals. Her body had an adverse reaction to one of those medications, which motivated her to try alternative medications and therapies. Lelehnia began to use the many tools her mother taught her in healing. Cannabis was one of those tools. She is now walking and thriving in life. Lelehnia, believes cannabis, CBDs, and other compounds of the plant being discovered, are a large part of her ability to thrive. Her mind would forever be changed after experiencing the plants healing properties – a cannabis advocate was born.

In 2005, she started growing her own medicine and providing for a local dispensary, The Hummingbird Healing Center. Immediately she began to experience the many draw backs of an unregulated industry. In Oct of 2014 she became involved with a political organization California Cannabis Voice Humboldt, by Dec she was elected the first board Chair and President. In January of 2015 co-founded the CCVH-Women's Alliance with two other women. Lelehnia played a key role in bringing together the local cannabis farmers, local business owners, and politicians to the same table, working together, to establish local and state cannabis regulations. Lelehnia continues to help her community transition by being involved in a women's think tank, "Women Cultivating Community", and working with local brands as they emerge into the main stream market. She was just recently appointed the role of a Human Rights Commisioner in her community.

Inspired by her county's history, and affinity for cannabis as a healing plant, she was compelled to launch Humboldt Grace, beyond the leaf. A way to allow her to help others discover the same health benefits that provided her a road to recovery. A way for Lelehnia to help her community continue to

thrive through legalization.

Now Lelehnia speaks on her culture, works with clients transitioning to legalization, and helps patients design small systems that work with their disabilities. Lelehnia has a social media network with over 4,000 1st person She has been featured in national articles, and mentioned in a publication Weed Wars by Peter Hetch. Lelehnia is considered a leader of cannabis and community advocacy at local, state, and national levels.
