**RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS
AMENDING RESOLUTION No. 22-03 (Compensation Plan for Management &
Confidential Employees)**

WHEREAS, the Board of Supervisors of the County of Humboldt (County) is authorized by the provisions of Section 25300 of the Government Code of the State of California to provide for the number, compensation, tenure, appointment and conditions of employment of County employees by resolution; and

WHEREAS, on January 4, 2022, the Board of Supervisors adopted Resolution No. 22-03, providing for the implementation of the January 1, 2022 – December 31, 2024 Compensation Plan for Management & Confidential Employees; and


WHEREAS, the Board of Supervisors desires to amend Resolution No. 22-03, providing for the implementation of the January 1, 2022 – December 31, 2024 Compensation Plan for Management & Confidential Employees to adopt the job classification of Senior Human Resources Analyst; and

WHEREAS, California Employees Retirement System (CalPERS) does require all government agencies to provide and make available to the public the salary of all full-time, part-time employees and Elected Officials in a single salary format specified by CalPERS; and

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors approves amendments to Resolution No. 22-03 to:

1. Adopt the new job specification for Senior Human Resources Analyst (class 0688, salary range 488) into the salary range and classification plan effective immediately (Attachment 2 to the report of this same date); and
2. Approving the amendment of the January 1, 2022 – December 31, 2024 Compensation Plans for Management & Confidential Employees adding the new job specification for Senior Human Resources Analyst; and
3. Adopt a Comprehensive Compensation Schedule and Classification Summary effective March 20, 2022 (Attachment 3 to the report of this same date).
