**RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS AUTHORIZING AN EXCEPTION TO THE ONE HUNDRED EIGHTY (180) DAY WAIT PERIOD OF THE CALIFORNIA PUBLIC EMPLOYEES RETIREMENT SYSTEM PURSUANT TO CALIFORNIA GOVERNMENT CODE SECTIONS 7522.56 AND 21224**

**WHEREAS**, in compliance with Government Code section 7522.56 the Humboldt County Board of Supervisors must provide California Public Employees Retirement System (CalPERS) this certification resolution when hiring a retiree before one hundred eighty (180) days has passed since her retirement; and

**WHEREAS**, Patricia Sennott retired from the Humboldt County Department of Public Works in the position of Office Assistant II, effective November 12, 2021; and

**WHEREAS**, California Government Code Section 7522.56 requires the post-retirement employment commence no earlier than one hundred eighty (180) days after the retirement date, which is May 12, 2022, without this certification resolution; and

**WHEREAS**, California Government Code Section 7522.56 provides that this exception to the one hundred eighty (180) day wait period shall not apply if the retiree accepts any retirement-related incentive; and

**WHEREAS**, the Humboldt County Board of Supervisors, the Humboldt County Department of Public Works and Patricia Sennott certify that Patricia Sennott has not and will not receive a Golden Handshake or any other retirement-related incentive; and

**WHEREAS**, the Humboldt County Board of Supervisors hereby appoints Patricia Sennott as an extra help retired annuitant to perform the duties of Office Assistant II for the Humboldt County Department of Public Works under California Government Code Section 21224, effective December 7, 2021; and

**WHEREAS**, the entire employment agreement, contract or appointment document between Patricia Sennott and the Department of Public Works has been reviewed by this body and is included herein; and

**WHEREAS**, no matters, issues, terms or conditions related to this employment appointment have been or will be placed on a consent calendar; and

**WHEREAS**, the employment appointment shall be limited to nine hundred sixty (960) hours per fiscal year; and

**WHEREAS**, the compensation paid to retirees cannot be less than the minimum nor exceed the maximum monthly base salary paid to other employees performing comparable duties, divided by 173.333 to equal an hourly rate; and

**WHEREAS**, the maximum base monthly salary for this position is Three Thousand One Hundred Nineteen Dollars and One Cent (\$3,119.01) per month and the hourly equivalent is Seventeen Dollars and Ninety-Nine Cents (\$17.99) per hour, and the minimum base monthly salary for this position is Two Thousand Four Hundred Thirty Dollars and Sixty Cents (\$2,430.60) per month and the hourly equivalent is Fourteen Dollars and Two Cents (\$14.02) per hour; and

**WHEREAS**, the hourly rate paid to Patricia Sennott will be Seventeen Dollars and Ninety-Nine Cents (\$17.99) per hour; and

**WHEREAS**, Patricia Sennott has not and will not receive any other benefit, incentive, compensation in lieu of benefit or other form of compensation in addition to this hourly pay rate.

**NOW, THEREFORE, BE IT RESOLVED** that the Humboldt County Board of Supervisors hereby certifies the nature of the appointment of Patricia Sennott as described herein and detailed in the Agenda Item related hereto, is necessary to fill the critically needed position of Office Assistant II in the Humboldt County Department of Public Works by December 7, 2021 because Patricia Sennott has knowledge and skills related to the duties of the Humboldt County Department of Public Works and will be able to provide continuity while new staff is hired and trained.
