You may force entry into the main structure and any outbuildings pursuant to this warrant located on the property to confirm conditions cited. You may perform any and all other acts reasonably necessary to determine whether conditions on the specified property are in violation of Humboldt County Codes. This warrant is effective from the date hereof for a period not to exceed fourteen (14) days. Said inspection shall not be made between 6:00 p.m. and 8:00 a.m. of the succeeding day and may be made in the absence of the owner/occupant(s). This warrant shall be returned to the Clerk of the Humboldt County Superior Court after it has been served.

You shall advise the owner/occupant(s) that a willful refusal to permit the inspection authorized by this warrant is a misdemeanor pursuant to Section 1822.57 of the Code of Civil Procedure.
