What is your vision for the Headwaters Fund Board?

My vision for Humboldt County is a place with increased economic opportunity, prosperity, and quality-of-life for future generations. As someone who loves technology and history, preserving a balance between renewing and keeping values is paramount. I believe in a community that supports organizations and businesses that add value to the community rather than extract from it, and I see the Headwaters Fund Board as this kind of enterprise.

How would you work with other Board members to arrive at decisions?

It depends on the other board members' character, knowledge, and time available. Ideally, after listening and dialoguing, we would agree on facts and then logically work toward conclusions and agree on a course of action

Describe area(s) of expertise/contribution you feel you can make:

I have expertise in the areas of public health (MPH degree) and project management (engineer in the military, rank of Major). I've also had the opportunity to study and practice knowledge management (KM), specifically assisting groups to visualize and understand project nuances through the production of dashboards, charts, and statistical analysis. I have traveled to 33 countries and throughout the U.S.A., and I have had the opportunity to engage in meaningful conversations and experiences with public works departments and local leaders regarding how projects affect the quality of life in communities. Because of my experience in decision making processes and concept visualization, I would be able to help the board do research, conduct analysis, and make presentations.

What role would you play on the Board?

I don't know what role I would play on this board, but in the Human Rights Commission I have been a key person in integrating technology to improve access and information management. I introduced Zoom to the Commission before the pandemic started, and we are now using it to maintain our public meeting schedule and communicate between board members. I helped Commissioners that are technologically challenged learn to use Zoom and cloud-based filing systems. I created dashboards for different ad hoc committees to better manage time and information. I also assisted in creating a web page for the anti-trafficking committee that connects victims with resources. I am a strong believer that having good, accessible, and well-organized information is paramount to effective leadership, and I strive to improve myself and others in this arena.

How much time would you have for the Headwaters Fund Board per month?

To a certain degree it depends on what the board is doing. I strongly believe in civic duty and take serving on the board seriously. My experience has been on committees and boards I have over a 90% attendance rate to meetings and usually dedicate two to three hours for every hour spent in the committee doing research and going over minutes. Sometimes this time requirement increases if I am put in an ad hoc committee for a Commission. I do not take lightly being part of an Ad-hoc committee, as I know that there is usually a serious time requirement for an ad hoc committee to perform well.

What are your other time commitments?

I have control over my own schedule. I belong to the Rotary Club, Elks Lodge and sons of Italy, but these organizations will take second place to the board if selected. I belong to the Human Rights Commission Which takes five hours a month of my time. I own a store but do not serve as a frontline person so also have control over my schedule. I have no children or pets.

BUSINESS MANAGEMENT.

1975 to 2003. Bug Press, Inc. I was General Manager/Co-owner of Bug Press, a commercial design and printing company, for 28 years. I was responsible for customer relations and for the administrative, financial and personnel aspects of the business.

ECONOMIC DEVELOPMENT.

2003 to 2006. Arcata Economic Development Corporation (AEDC).

I was the Executive Director and responsible for management of AEDC corporate functions and for oversight of AEDC policy objectives. This position was responsible for supervising a staff of six and had the authority to make day-to-day operating decisions consistent with adopted Board policy. The Executive Director planned, implemented and monitored AEDC projects and programs related to economic development and lending activities; and, was responsible for securing and administering public and private financing, grants and contracts. AEDC had assets of approximately \$4.8 million and an annual operating budget of \$650,000.

1978 through 1996. Arcata Economic Development Corporation (AEDC).

I was a charter member of the Corporation in 1978 and served for approximately eight years on the Board of Directors during this period.

WASTE MANAGEMENT.

2011 to 2013. Humboldt Waste Management Authority (HWMA).

I served as the Special Projects Manager of HWMA from 2011 through March 2013. The Special Projects Manager was responsible for helping the Interim Executive Director maintain continuity with many ongoing projects and aiding the Board of Directors in their search for a permanent Executive Director.

2006 to 2011. Humboldt Waste Management Authority (HWMA).

I served as the Executive Director of HWMA from 2006 through 2011. HWMA is a Joint Powers Authority composed of five cities and the County of Humboldt. The Executive Director was responsible for management of HWMA corporate functions and for oversight of HWMA Board policy objectives related to solid waste, recycling, electronic waste, hazardous waste and other special waste categories. This position was responsible for supervising a staff of 28 and had the authority to make day-to-day operating decisions consistent with adopted Board policy. HWMA had assets of approximately \$22 million and an annual operating budget of approximately \$10 million.

1996 to 2002. Humboldt Waste Management Authority (HWMA).

As the representative from the City of Arcata I participated in the development of the original Joint Powers Authority and assumed the City's seat on the Board of Directors, serving one term as Board Chair. During those six years I was involved in the preparation and adoption of the JPA agreement, the development of the organizational structure, the development of a Request for Proposals and selection of a transfer station partner, the permitting and construction of an interim transfer station, the purchase and construction of a permanent transfer station, and the partial closure of Cummings Road Landfill.

ELECTED OFFICIAL.

1994 to 2002. Arcata City Council. I served eight years on the City Council, three of those years as Mayor. During my two terms I developed an ability to work with a variety of staff and elected officials and became conversant with fund accounting and a plethora of regulations. I represented the City on:

Humboldt Waste Management Authority; Humboldt County Association of Governments; and Redwood Region Economic Development Commission.

COMMUNITY PLANNING.

2002 to 2003. Planwest Partners. As a Senior Planner from December 2002 through October 2003 I worked on a number of projects in the City of Rio Dell. We helped the City enact a building moratorium, revise and adopt a new General Plan, revise land use ordinances and review land use projects.
