

**SECOND AMENDMENT
AGREEMENT FOR CONSULTANT SERVICES
BY AND BETWEEN
COUNTY OF HUMBOLDT
AND
QUINCY ENGINEERING, INC.
AS ASSIGNED TO
CONSOR NORTH AMERICA, INC.
FOR
ON-CALL BRIDGE PROGRAM MANAGEMENT, STRUCTURAL ANALYSIS, DESIGN
ENGINEERING AND OTHER SERVICES**

This Second Amendment to the Agreement for Consultant Services dated June 25, 2019, by and between the County of Humboldt, a political subdivision of the State of California, hereinafter referred to as "COUNTY," and Quincy Engineering, Inc., a California corporation, as assigned to Conсор North America, Inc., an Illinois corporation, hereinafter referred to as "CONSULTANT," is entered into this 28 day of February 2023.

WHEREAS, on June 25, 2019, COUNTY and CONSULTANT entered into an Agreement for Consultant Services regarding the provision of on-call bridge program management, structural analysis, design engineering and other related services ("Consultant Services Agreement"); and

Whereas, on September 1, 2020, COUNTY and CONSULTANT amended the Consultant Services Agreement in order to extend the term thereof; and

WHEREAS, pursuant to Article 1, Provision G of that agreement CONSULTANT must obtain the COUNTY's written approval to assign obligations thereunder; and

WHEREAS, the COUNTY now explicitly agrees in writing to such an assignment of CONSULTANT's obligations from Quincy Engineering, Inc. to Conсор North America, Inc. pursuant to Article 1, Provision G of the Consultant Services Agreement.

NOW THEREFORE, the parties mutually agree as follows:

1. Article 1 – Introduction of the Consultant Services Agreement is hereby amended to read as follows:

ARTICLE I – INTRODUCTION

- A. The Project Manager for CONSULTANT will be Jason Jurens. The Contract Administrator for COUNTY will be Tony Seghetti, Deputy Director of Public Works or a designee thereof.
2. Article XIX – Insurance and Indemnification of the Consultant Services Agreement is hereby amended to read as follows:

ARTICLE XIX – INSURANCE AND INDEMNIFICATION
