Purchase of One (1) 2025 Caterpillar CS7 Paving and Compaction Roller to replace the existing 2005 Bomag Compaction Roller (4/5 Vote Required)

- 2. Declare One (1) 2005 Bomag Compaction Roller as surplus equipment. (4/5 Vote Required)

# **DISCUSSION:**

The Humboldt County Department of Public Works - Roads Measure O is requesting authorization to purchase one (1) 2025 Caterpillar CS7 Paving and Compaction Roller from Peterson Caterpillar, a member of Sourcewell. The above-referenced equipment will replace one existing 2005 Bomag Compaction Roller to meet current State of California emissions requirements. Should the Board choose to declare the existing 2005 Bomag Compaction Roller as surplus, it will be sold at auction.

### FINANCIAL IMPACT:

Narrative Explanation of Financial Impact:

The total cost to purchase one Caterpillar CS7 Paving and Compaction Roller is \$242,653.89. For FY 25-26, Public Works budgeted \$2,000,000.00 to purchase the Jaw and Cone Crusher equipment. The equipment purchase total was \$1,516,175.57 with a net savings of \$483,824.43. Public Works would like to use \$242,653.89 of the net savings to purchase the Caterpillar CS7 Paving and Compaction Roller.
