WHEREAS, the Redwood Art Association was founded by Susan and David Strobe, Hobart Brown, June Beal, Floyd Bettiga, Tom Knight, Martin Wong, Roger Cinnamond, Check Ellsworth, Mel Shuler, Jack Mays and Curtis Otto; and

WHEREAS, the Redwood Art Association currently has 325 members, representing artists from all parts of Humboldt County; and

WHEREAS, the Association now holds 12 exhibitions per year at their Eureka gallery, and curates art at the foot of C Street in Eureka, at the Hagopian Gallery inside the Humboldt County Library, and "Art at the Airport" at the California Redwood Coast Humboldt County Airport.
