**RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS AUTHORIZING THE HUMBOLDT COUNTY DISTRICT ATTORNEY'S OFFICE TO APPLY FOR, ACCEPT AND ADMINISTER FUNDING MADE AVAILABLE BY THE CALIFORNIA GOVERNOR'S OFFICE OF EMERGENCY SERVICES THROUGH THE CHILD ADVOCACY CENTER PROGRAM**

**WHEREAS**, the County of Humboldt, by and through the Humboldt County District Attorney's Office – Child Abuse Services Team, is required to provide comprehensive services to victims and witnesses of all types of violent crime, pursuant to California Penal Code Sections 11166.4, 13835.4 and 13835; and

**WHEREAS**, the County of Humboldt, by and through the Humboldt County District Attorney's Office – Child Abuse Services Team, desires to undertake a project designated as the Child Advocacy Center Program to be funded in part from funds made available by the California Governor's Office of Emergency Services.

**NOW, THEREFORE, THE HUMBOLDT COUNTY BOARD OF SUPERVISORS HEREBY RESOLVES AS FOLLOWS:**

1. The Humboldt County District Attorney's Office is hereby authorized and directed to apply for, accept and administer funding made available by the California Governor's Office of Emergency Services through the Child Advocacy Center Program from April 1, 2023 through March 31, 2028.
2. The Humboldt County District Attorney, the Humboldt County Auditor-Controller and County Administrative Office, and/or designees thereof, are hereby authorized to execute any and all certifications, agreements, amendments, modifications and other documents required, or deemed necessary or appropriate, to apply for, accept, administer funding made available by the California Governor's Office of Emergency Services through the Child Advocacy Center Program.
3. The County of Humboldt hereby represents and certifies that all Child Advocacy Center Program funding awarded to the Humboldt County District Attorney's Office will be used in a manner consistent, and in compliance, with any and all applicable local, state and federal laws, regulations, requirements and standards, as well as any and all applicable agreements between the County of Humboldt and the California Governor's Office of Emergency Services.
4. The County of Humboldt hereby represents and certifies that the Child Advocacy Center Program funding awarded to the Humboldt County District Attorney's Office will not be used to supplant expenditures controlled thereby.


