5. HVAC: DUCTED PACKAGE SYSTEM

6. INSULATION: R-38 CEILING, R-21 EXTERIOR WALLS, R-15 INTERIOR WALLS

7. INTERIOR MATERIALS: ACOUSTIC CEILING AND DRYWALL AT COMMUNITY SPACES, VINYL PLANK FLOORING






