**RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS
AMENDING RESOLUTION NO. 18-81 AND RESOLUTION 19-76 RELATED TO THE
SOCIAL WORKER III CLASSIFICATION WITHIN THE COMPENSATION PLANS
FOR AMERICAN FEDERATION OF STATE, COUNTY & MUNICIPAL EMPLOYEES**

WHEREAS, the Board of Supervisors of the County of Humboldt (County) is authorized by the provisions of Section 25300 of the Government Code of the State of California to provide for the number, compensation, tenure, appointment and conditions of employment of County employees by resolution; and

WHEREAS, on August 21, 2018, the Board of Supervisors adopted Resolution No. 18-81, providing for the implementation of the October 1, 2017 – December 31, 2020 Compensation Plans for designated American Federation of State, County & Municipal Employees (AFSCME); and

WHEREAS, on August 20, 2019, the Board of Supervisors adopted Resolution No. 19-76, which added the classification of Social Worker III to the AFSCME compensation plan; and

WHEREAS, the Board of Supervisors desires to amend Resolutions No. 18-81 and 19-76 to amend the salary range and unit for the Social Worker III classification.

NOW, THEREFORE, BE IT RESOLVED that:


1. The Board of Supervisors approves the amendment to Resolution No. 18-81 and 19-76 to amend the classification of Social Worker III from class 0727, salary range 475, unit 219 to class 0727, salary range 400, unit 004 within the classification plan found at Appendix A of the July 1, 2017 – June 30, 2020 American Federation Of State, County & Municipal Employees (AFSCME) Memorandum of Understanding; and
2. These changes shall become effective immediately following Board approval of this resolution.
