Hello everyone,

I was the caller ending in 7094 at today's meeting. I kept pressing \*6 but was unable to get through. Instead I'll just say what I have to say here.

The issue I'd like to address is the fact that 50 percent of the County has yet to get vaccinated. I have to admit I have found the position of the Board and some of the comments disturbing to say the least. What I see is a huge game of cover your butts. Dr. Hoffman follows whatever comes from the state health department and the CDC. The board members follow whatever Dr. Hoffman says. This way, if it's wrong, you can just say you were following the "experts". The problem with this is the experts have been continuously wrong. Before the election we heard both Biden and Harris say they wouldn't trust the "Trump vaccine" as if he was in the lab making a vaccine. This notion is ludicrous at best. Then all of a sudden when they took office, it was completely safe. Then Biden said if we got the vaccine we didn't have to wear a mask, now that has changed.
