24 I. Proof, by declaration, made this day before me that there is cause for  
25 believing that there are conditions of nonconformity in and upon the premises located at 6608

27 belongs to Lucas Bode, which constitute violations of Uniform Housing Code ("UHC") 1001 &  
28 California Health & Safety Code ("H&S") 17290.3 – Substandard Housing; UHC 1001.11 and  
H&S 17920.3 – Unsanitary Conditions; HCC 331-28 – Construction of Building/Structure in  
Violation of Building, Plumbing and/or Electrical Codes; HCC 312-3 – Development within  
Coastal Zone Without Permit(s); HCC 521-4 – Improper Storage and Removal of Solid Waste;  
HCC 354-1 - Junk and/or Inoperable Vehicles; along with HCC 352-3(t)(3) – Failure to Comply  
with the Chief Building Official's Order.

1 **YOU ARE HEREBY COMMANDED** to enter and inspect the premises described  
2 below and to take evidence, as authorized and required by the Code of Civil Procedure Section

17 Department of Health and Human Services Staff (including but not limited to Mental Health,  
18 Social Services & Environmental Health), Humboldt Bay Fire Department and Representatives  
19 of Wahlund Construction, Inc., to assist you in conducting the inspection upon the above-  
20 described property, including the taking of photographs of the property and the conditions found  
21 upon it without limitation.

22 You may force entry onto the property, including the cutting of chains or locks on gates,  
23 if the owner/occupant(s) are not present to provide entry. You may force entry into the  
24 constructed structure pursuant to this warrant located on the property. You may perform any and  
25 all other acts reasonably necessary to determine whether conditions on the specified property are  
26 in violation of Humboldt County Codes. This warrant is effective from the date hereof for a  
27 period not to exceed fourteen (14) days. Said inspection shall not be made between 6:00 p.m.  
28 and 8:00 a.m. of the succeeding day and may be made in the absence of the owner/occupant(s).
