Resolution by the Board of Supervisors of the County of Humboldt to revoke the The Country Club, LLC Conditional Use Permit, Record Number PLN-12985-CUP

WHEREAS, on December 14, 2017 the Humboldt County Planning Commission approved the Conditional Use Permit for record number PLN-12985-CUP for a new cannabis dispensary; and

**WHEREAS,** after the close of all appeal periods the Conditional Use Permit was issued to Eagle One LLC, with an effective date of December 29, 2017; and

WHEREAS, the dispensary began operation and vested their permit; and

WHEREAS, on October 24, 2018, Eagle One, LLC filed a Restated Articles of Organization with the California Secretary of State office changing the business name to The Country Club, LLC; and

WHEREAS, on May 8, 2024 the County received notice from the property owner that The Country Club, LLC was evicted and no longer authorized to conduct the operation on the premises; and

**WHEREAS,** the permit holder did not respond to a request from the Planning and Building Department to withdraw the permit; and

WHEREAS, on May 10, 2024, a Permit Revocation Notice was sent to the permit holder, The Country Club, LLC, via USPS certified mail, return receipt requested, to the address on file stating the use for which the permit was granted has ceased to exist and that the Humboldt County Planning and Building Department would be scheduling a public hearing before the Board of Supervisors on June 11, 2024, with a recommendation to revoke the Conditional Use Permit; and

**WHEREAS,** on May 13, 2024, the Planning and Building Department posted a Permit Revocation Notice at the building entrance stating the permit was being scheduled for a hearing with a recommendation to revoke the Conditional Use Permit; and

**WHEREAS**, the Board of Supervisors held a duly-noticed public hearing on June 11, 2024, and reviewed, considered, and discussed the application and appeal for the Special Permit; and reviewed and considered all public testimony and evidence presented at the hearing.
