
Subject: Lack of a Moral Compass

Humboldt County has a systemic "Lack of a Moral Compass".

Examples such as the not so honorable Judge Gregory J. Kreis. He is still observed up on the Second floor where our Court system is. He was rightfully removed from the Court system after causing irreputable harm to the Citizens of Humboldt County. Especially Children and families that were subject to his "Lack of a Moral Compass".

Another example of a "Lack of a Moral Compass" is Humboldt County-ex employee Joseph Hale. He is an ex-Humboldt County Family Law mediator, CCRC. He was terminated with cause fro CWS in 2012. He then was hired as a Court Mediator for Child Custody cases in the local Court system. He fit right in with Ex Judge Gregory J. Kreis. He is now a convicted Sex offender. It is a public perception that County, and Court staff were aware of his criminal activities for years, and did not act in a timely manner.

My Third example of a "Lack of Moral Compass" is DHHS Director Connie Beck. It is common knowledge verified by Supervisor Rex Bohn, Reporter Ryan Burns, and others that she stole a horse, which she returned to its rightful owner Erin Beth McClure rather than face prosecution for the Crime. It is public perception that she and some CWS staff do not respect ICWA, family unification, or the obligation to protect children from being placed in the home of an accused pedophile.

Another example of a "Lack of Moral Compass" are some CWS Staff who go to court and make fraudulent statements to the Court, withhold relevant information, fabricate false accusations, and only present required information that supports their narrative. This results in Indigenous Children placed in a home with someone they have accused of sexually and mentally abusing them. Some CWS workers have done nearly everything possible to preclude Tribal participation (Their Legal Right) under ECWA.

Whether it is just "Turning a Blind Eye" or actively participating in this travesty, it is public perception that Humboldt County, County Council, HR department. The District Attorney, Minor Council, and others "Lack the Moral Compass" to fulfill their obligation to protect the Counties most vulnerable.

A "Moral Compass" is "A guiding framework of principles, beliefs, and values that help you distinguish right from wrong" a person who lacks "Moral Compass", "Often exhibits excessive self-centeredness. They consistently put their needs, wants and feelings above everyone else's. Another term for this is "Empathy Deficit Disorder". It is no excuse.

The perceived pedophile has threatened to come to the Supervisors Chamber and speak. I look forward to him doing so. Maybe he will bring his Father who texted me the following threats;

"I don't know how you plan to address your end. if you chose local burial, I promise you that my son and grandson will simultaneously piss on your Grave. You won't care, but we will."

"You have wrongly attacked my family publicly. Consequences."

"Ill revisit you after we have total custody."

"You're already on borrowed time."

"I'm going to watch you burn"

These statements are clear criminal threats, intended to intimidate, harass, and silence myself and the loving mother of the Children (Who has not been even allowed communication with the abused Children for in excess of 160 days.)

I have been assisting the Loving Mother as an advocate. I am also a potential witness in this matter. It is a sad state of affairs when the above-mentioned individuals and departments empower offenders to participate in perceived witness intimidation.

Lastly, I wish to thank Humboldt County Sheriffs office for initiating a timely investigation into my complaint regarding my concerns. I take this as a death threat should I not cease to assist the Loving Mother, or testify in this matter. Officer Joseph Souza responded promptly, and professionally. I hope for a timely investigation in this matter. I fear for the life of The Loving Mother, and the abused Children. I can take care of myself with help from Law enforcement. I do sleep somewhat better knowing that Sheriff Billy Honsal,s team is involved.
