**RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS
AMENDING RESOLUTION NO. 18-81 (MEMORANDUM OF UNDERSTANDING FOR
AMERICAN FEDERATION OF STATE, COUNTY & MUNICIPAL EMPLOYEES
UNITS 1-4) AND ADOPTING A COMPREHENSIVE SCHEDULE AND
CLASSIFICATION SUMMARY**

WHEREAS, the Board of Supervisors of the County of Humboldt (County) is authorized by the provisions of Section 25300 of the Government Code of the State of California to provide for the number, compensation, tenure, appointment and conditions of employment of County employees by resolution; and

WHEREAS, on August 21, 2018, the Board of Supervisors adopted Resolution No. 18-81, providing for the implementation of the October 1, 2017 – December 31, 2020 Memorandum of Understanding for designated American Federation of State, County & Municipal Employees; and

WHEREAS, the Board of Supervisors desires to amend Resolution No. 18-81, providing for the implementation of the October 1, 2017 – December 31, 2020 Compensation Plans for designated American Federation of State, County & Municipal Employees.

WHEREAS, California Employees Retirement System (CalPERS) does require all government agencies to provide and make available to the public the salary of all full-time, part-time employees and Elected Officials in a single salary format specified by CalPERS; and

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors approves amendments to Resolution No. 18-81 to:

1. Adopt the amended and retitled job classification of Youth Support Specialist I/II (class #1735, salary range 369/389, Unit 1) (replacing Children Center Specialist I/II) into the classification plan effective immediately; and
2. Adopt the amended and retitled job classification of Senior Youth Support Specialist (class #1736, salary range 409, Unit 1) into the classification plan effective immediately.

The Board of Supervisors adopts a Comprehensive Compensation Schedule and Classification Summary (attachment 3 of the report this date) effective May 18, 2021.


