<u>DISCUSSION</u>: Two (2) vacancies will be occurring on June 30, 2018 on the Forestry Review Committee due to term expirations of At-Large members Yana Valachovic and Chris Carroll. Ms. Valachovic was appointed in 2006 and reappointed in 2010, and 2014. Mr. Carroll was appointed in 2000 and has been reappointed in 2002, 2006, 2010 and 2014. Both has been a valuable asset to this Committee and both would like continue their roles on the Forestry Review Committee.

Unless the Clerk of the Board is notified, not more than three days prior nor more than seven days subsequent to the date of this meeting, of a desire to calendar this matter for further discussion, any Board member may bring forward an item to reappoint these members or appoint any qualified person to fill these vacancies. QUALIFICATIONS:

Registered professional foresters (RPF) in good standing working in Humboldt County. An RPF in good standing is an individual who holds a current license issued by the Board of Forestry, and who does not have a currently outstanding licensing action issued by the Board of Forestry.

Four (4) Years (expire on 6/30 of the 4th year)
