A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF HUMBOLDT HEREBY AUTHORIZES THE SUBMITTAL OF AN APPLICATION TO THE CALIFORNIA STATE DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT FOR FUNDING UNDER THE LOCAL HOUSING TRUST FUND PROGRAM (LHTF); THE EXECUTION OF A STANDARD AGREEMENT IF SELECTED FOR SUCH FUNDING AND ANY AMENDMENTS THERETO; AND ANY RELATED DOCUMENTS NECESSARY TO PARTICIPATE IN THE LHTF PROGRAM.

WHEREAS the Department of Housing and Community Development (Department) is authorized to provide up to \$57 million under the Local Housing Trust Fund ("LHTF") Program from the Veterans and Affordable Housing Bond Act of 2018 (Proposition 1) (as described in Health and Safety Code section 50842.2 et seq. (Chapter 365, Statutes of 2017 (SB 3)) ("Program");

WHEREAS the State of California (the "State"), Department issued a Notice of Funding Availability ("NOFA") dated 4/5/2022 under the LHTF Program;

WHEREAS, the County of Humboldt, a political subdivision of the State of California, wishes to apply for and is eligible to receive an allocation of funds through LHTF Program for the purpose of administering one or more eligible activities using program funds;

WHEREAS the Department may approve funding allocations for the LHTF Program, subject to the terms and conditions of Health & Safety Code Section 50842.2, the LHTF Program Guidelines, NOFA, Program requirements, the Standard Agreement and other related contracts between the Department and LHTF award recipients;

WHEREAS, the on May 10, 2022 Board of Supervisors of the County of Humboldt allocated \$1,500,000 of American Rescue Plan Act (ARPA) Funding as eligible 1:1 match for LHTF Program eligible activities; and

WHEREAS, the Board of Supervisors of the County of Humboldt wishes to apply to obtain from HCD an allocation of LHTF program funds in the amount of \$1,500,000 to establish the Humboldt County Housing Trust Fund.

NOW, THEREFORE, BE IT RESOLVED, DETERMINED AND ORDERED by the Board of Supervisors as follows:

- 1. The Board of Supervisors has reviewed and hereby approves the LHTF Program application for the April 5, 2022, LHTF NOFA;
- 2. If the County of Humboldt receives an award of LHTF funds from the Department pursuant to the above referenced LHTF NOFA, the Board of Supervisors represents and certifies that it will use all such funds on Eligible Projects in a manner consistent and in compliance with all applicable state and federal statutes, rules, regulations, and laws, including, without limitation, all rules and laws regarding Program, as well as any and all contracts Applicant may have with the Department ("Eligible Project");
- 3. The Board of Supervisors hereby authorizes and directs the Planning and Building Department to act as the fund manager in connection with the LHTF funds making loans to

Eligible Projects pursuant to the above-described Notice of Funding Availability in an amount not to exceed \$1,500,000 (the "LHTF Award"); and

- 4. The Board of Supervisors hereby agrees to match on a dollar-for-dollar basis the LHTF Award pursuant to Guidelines Section 104. Applicant hereby agrees to utilize matching funds on a dollar-for-dollar basis for the same Eligible Project for which Program Funds are used, as required by Health & Safety Code Section 50843.5(c). A summary of the how program and matching funds will be used is incorporated in this Resolution as Exhibit 1; and
- 5. Pursuant to Exhibit 1 and the Board of Supervisor's certification in this resolution, the LHTF funds will be expended only for Eligible Projects and consistent with all program requirements; and
- 6. The County of Humboldt shall be subject to the terms and conditions as specified in the Standard Agreement, Health & Safety Code Section 50842.2 and LHTF Program Guidelines; and
- 7. The Board of Supervisors hereby adopts the Uniform Multifamily Regulations (UMR's) as the loan guidelines, underwriting standards, and procedures for the Humboldt County Housing Trust Fund. The UMR's are incorporated in this Resolution as Exhibit 2; and
- 8. The Board of Supervisors hereby authorizes and directs the Planning and Building Director to execute the LHTF Program Application, the LHTF Standard Agreement and any subsequent amendments or modifications thereto, as well as any other documents which are related to the Program or the LHTF Award to the County of Humboldt, as the Department may deem appropriate.
