RESOLUTION NO. 25 –

**RESOLUTION OF THE BOARD OF SUPERVISORS OF THE COUNTY OF HUMBOLDT
REVOKING THE ZONEING CLEARANCE CERTIFICATE, RECORD NUMBER PLN-12187-ZCC
FOR APN 220-261-075.**

WHEREAS, On, December 21, 2016, Wendy Kornberg submitted an application for a permit for cannabis cultivation for APN 220-261-075; and

WHEREAS, on May 4, 2022, the Zoning Clearance Certificate was approved, for a Zoning Clearance Certificate which allowed for cultivation at a receiving site as part of a Retirement, Remediation, and Relocation (RRR) to allow 20,000 square feet (SF) of outdoor cannabis cultivation on APN 223-075-012 that will be retired from APN 220-261-075; and

WHEREAS, on October 24, 2023, the Board of Supervisors received a report that there are approximately \$14 million in unpaid Measure S Taxes and \$2.1 million in unpaid permit processing costs associated with cannabis permit applications; and

WHEREAS, the Board of Supervisors provided a series of deadlines for cannabis permit holders to pay for their permit processing costs and establish a payment plan for payment of Measure S taxes. The farmers were given six months until March 31, 2024, to pay their permit costs and enter an agreement to pay their outstanding taxes.

WHEREAS, in response to the Board direction, a series of communications was provided to applicants and permit holders to inform them of the needed actions and deadlines to keep their permits in good standing. This included a detailed January 9, 2024, letter, subsequent emails, and social media announcements encouraging applicants and permit holders to bring their account current before March 31, 2024; and

WHEREAS, the above referenced permit had unpaid Department invoice balance of \$1,696.65.

WHEREAS, a letter was sent to the permit holder on June 18, 2024 providing notice that the permit had been suspended for lack of payment of the past due balance and that the permit would be scheduled for revocation if not resolved within 90 days; and

WHEREAS, the Board of Supervisors held a duly-noticed public hearing on April 22, 2025, and reviewed, considered, and discussed the revocation for the Zoning Clearance Certificate and reviewed and considered all public testimony and evidence presented at the hearing.

| EVIDENCE: | Per the operational conditions under PLN-12187-ZCC, the applicant is responsible for costs for post-approval review for determining project conformance with conditions prior to release of building permit or initiation of use and at time of annual inspection. The permit holder has not adhered to this requirement to cover all costs generated during the life of this permit. This sum currently amounts to \$1696.65. |

- a. Revoke the Zoning Clearance Certificate for PLN-12187-ZCC on APN 223-075-012
