
1           4.     The INSPECTION WARRANT was served by Code Enforcement Investigator  
2 Sára Quenell on February 9, 2022, at about 10:00 a.m. Humboldt County Sheriff Office Deputies  
3 were present for security purposes. The following individuals were also present during the  
4 inspection: Code Compliance Officer Danielle Soto – Humboldt County Code Enforcement, Air  
5 Pollution Inspector Lloyd Green – North Coast Unified Air Quality Management District, Animal  
6 Control Officers Taylor Pedersen and Megan Nims – Humboldt County Sheriff's Office.

7           5.     The Property owner, Glenda Rasella, was present for the entirety of the inspection.  
8 The Property owner also had two friends present who stayed by the front gate of the property  
9 during the inspection.

10          6.     The Property was inspected, and evidence was found that confirmed the previous  
11 violations of the Humboldt County Code relating to the storage and removal of solid waste, junk  
12 vehicles, unsanitary conditions, animal keeping, maintaining a junkyard, and construction of a  
13 building/structure in violation of building, plumbing and/or electrical codes still existed on the  
14 Property.

15          7.     Said INSPECTION WARRANT is returned having been fully executed. I declare  
16 under penalty of perjury under the laws of the State of California that the foregoing is true and  
17 correct to the best of my knowledge.
