**RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS REGARDING THE
EXCHANGE OF PROPERTY TAX REVENUE AS A RESULT OF THE HUMBOLDT COMMUNITY
SERVICES DISTRICT'S APPLICATION TO ANNEX THE NORTH MCKAY RANCH SUBDIVISION**

WHEREAS, The Humboldt Community Services District ("HCSD") has initiated the process with the Humboldt County Local Agency Formation Commission ("LAFCO") for the annexation of the North McKay Ranch Subdivision, APN's 017-032-003, 017-071-009, 017-072-003, 017-073-007 and 017-073-008; and

WHEREAS, Revenue and Taxation Code Section 99 requires that local agencies affected by the proposed annexation must negotiate to determine the amount of property tax revenues to be exchanged between and among the local agencies; and

WHEREAS, Notwithstanding any other provision of law, the LAFCO Executive Officer shall not issue a certificate of filing pursuant to Section 56658 of the Government Code until the local agencies included in the property tax revenue exchange negotiation present resolutions adopted by each such agency agreeing to accept the exchange of property tax revenues; and

WHEREAS, If a special district involved in the negotiation (other than the district which will provide one or more services to the area where those services have not been previously provided) fails to adopt a resolution providing for the exchange of property tax revenue, the Board of Supervisors shall determine the exchange of property tax revenue for that special district; and

NOW, THEREFORE, IT IS HEREBY PROCLAIMED by Board of Supervisors of the County of Humboldt, and on behalf of each special district affected by the proposed annexation, hereby agrees to the property tax allocation set forth in Attachment A, be effective upon the recordation of the Executive Officer's Certificate of Completion for the subject activation of power:
