RESOLUTION NO. 22-70 of the Board of Supervisors of the County of Humboldt MAKING FINDINGS FOR ADOPTING AN ORDINANCE AMENDING SECTION 331-11 OF CHAPTER 1 OF DIVISION 3, TITLE III OF THE HUMBOLDT COUNTY CODE RELATING TO EMERGENCY HOUSING STANDARDS.

WHEREAS, the Humboldt County Board of Supervisors declared a Shelter Crisis on February 27, 2018 through its Resolution 18-15, which remains in effect until terminated by the Board; and

WHEREAS, the California Legislature passed AB 2553 (2020) requires the adoption and application of Emergency Housing Standards for emergency shelters developed under a Shelter Crisis Declaration on county-owned and county-leased land, and the Emergency Housing Standards Ordinance (Attachment 8) incorporates these standards by reference as Appendix O of the California Building Code and Appendix X of the California Residential Code into Section 331-11 of Title III, Division 3 of the Humboldt County Code;

NOW THEREFORE, be it resolved that the Board of Supervisors hereby:

1. Sets for adoption the amendments to the Building Code as set forth in the Ordinance Amending Section 331-11 of Chapter 1 of Division 3, Title III of the Humboldt County Code Relating to Emergency Housing Standards (Attachment 8) at least one week from this hearing date; and
2. Directs the Clerk of the Board to publish a Summary for Publication prior to adoption of the ordinance; and
3. Directs the Clerk of the Board to publish the Post-Adoption Summary of the Ordinance within fifteen (15) days after its passage.

The foregoing Resolution is hereby passed and adopted by the Board of Supervisors on June 7, 2022 by the following vote:
