ORDINANCE NO. 1169

AMENDING ORDINANCE NO. 519 TO REZONE PROPERTY IN THE BAYSIDE AREA

The Board of Supervisors of the County of Humboldt do ordain as follows:

SECTION 1. Section 304 of Ordinance No. 519 is hereby amended by rezoning the following area from an R-1-B-3 Zone to an R-S-B-5 (2-1/2 acre minimum) Zone:

BEGINNING at the northwest corner of Section 3, Township 5 North, Range 1 East, Humboldt Base and Meridian; thence east 1,485 feet; thence south 94 feet; thence south 80 degrees 30 minutes east 240 feet; thence south 61 degrees east 40 feet; thence south 49 degrees 52 minutes west 73.8 feet; thence south 24 degrees 56 minutes west 544 feet; thence south 210 feet; thence east 125 feet; thence south 192.59 feet; thence east 292 feet; thence south 316.44 feet to centerline of Golf Course Road; thence southeasterly along the centerline of Golf Course Road 2,750 feet more or less to the northeast corner of the northwest quarter of the southeast quarter; thence south 1,320 feet; thence west 2,640 feet thence north 1,795 feet; thence south 60 degrees west 552 feet; thence north 30 degrees west 138.3 feet; thence south 60 degrees west 191.5 feet; thence north 30 degrees west 35.6 feet; thence south 60 degrees west 106.6 feet; thence north 30 degrees west 260 feet to centerline of Golf Course Road; thence northwesterly along the centerline of Golf Course Road 290 feet; thence west 336 feet; thence north 700 feet; thence east 84.5 feet; thence north 1490 feet to point of beginning.

SECTION 2. This ordinance shall become effective thirty (30) days after the date of this enactment.
