**RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS REPEALING  
RESOLUTION NO. 14-25 AND ADOPTING A NEW COUNTY PURCHASING POLICY**

**WHEREAS**, on March 18, 2014 the Humboldt County Board of Supervisors ("Board") adopted the *County Purchasing Policy*, which combined several existing policies into one comprehensive purchasing policy; and

**WHEREAS**, several sections of the *County Purchasing Policy* are in need of modernizing, clarifications and updates in order to more effectively procure goods and services on behalf of the residents of Humboldt County; and


**WHEREAS**, the County of Humboldt endeavors to promote accountability for the expenditure of taxpayer funds and provide the best value for the county using lawful, transparent, and fair methods for the purchase of goods and services; and

**WHEREAS**, pursuant to Government Code sections 25500 et seq., the Board of Supervisors ("Board") establishes the duties and policies regarding the County Purchasing Agent; and

**WHEREAS**, the Purchasing Agent, by direction of the Board, shall implement and maintain a Purchasing Policy wherein are set forth methods and procedures for the acquisition of supplies, equipment, and services.

**NOW, THEREFORE, BE IT RESOLVED** that the County of Humboldt Board of Supervisors rescinds Resolution No. 14-25 and adopts the *County of Humboldt Purchasing Policy* attached hereto as Exhibit A.


