

ORDINANCE NO. 1444

AMENDING SECTIONS 221-4, 224-2, 225-2 AND 228-4 OF  
THE HUMBOLDT COUNTY CODE; CHANGING MEMBERSHIP ON THE  
HUMBOLDT COUNTY ANIMAL CONTROL ADVISORY COMMITTEE,  
THE HUMBOLDT COUNTY FISH AND GAME ADVISORY COMMITTEE,  
THE HUMBOLDT COUNTY FORESTRY COMMITTEE AND THE  
HUMBOLDT COUNTY COMMISSION ON HUMAN RIGHTS

The Board of Supervisors of the County of Humboldt do ordain  
as follows:

SECTION 1. Section 221-4 of the Humboldt County Code is

SECTION 2. Section 224-2 of the Humboldt County Code is  
hereby amended to read as shown on the attached revised page 36 of  
the Humboldt County Code.

SECTION 3. Section 225-2 of the Humboldt County Code is  
hereby amended to read as shown on the attached revised page 37  
of the Humboldt County Code.

SECTION 4. Section 228-4 of the Humboldt County Code is  
hereby amended to read as shown on the attached revised page 41  
of the Humboldt County Code.

SECTION 5. This ordinance shall become effective thirty (30)  
days after the date of its passage.





## CHAPTER 8

HUMBOLDT COUNTY COMMISSION ON HUMAN RIGHTS

## 228-1. ESTABLISHMENT OF COMMISSION.

The Humboldt County Commission on Human Rights is hereby established. (Ord. 1023 § 1, 4/22/75)

## 228-2. AUTHORITY FOR ESTABLISHMENT.

The Commission is established pursuant to Title 5, Division 1, Part 1, Chapter 1, Article 10 of the Government Code (§§ 50260-50265) and Section 31000.1 of the Government Code. (Ord. 1023 § 2, 4/22/75)

## 228-3. PURPOSE OF COMMISSION.

The Commission is established to aid in the eradication of discrimination in Humboldt County, with particular reference to housing, employment, education and public accommodation. The Board of Supervisors recognizes that such discrimination is harmful to those discriminated against and is ultimately harmful to the County, as a whole, due to the lack of utilization of the human potential of those subject to such discrimination, and further due to depreciated property values and the increased cost of governmental services such as law enforcement and welfare. Committees may be established by the Commission. (Ord. 1023 § 5, 4/22/75)

## 228-4. APPOINTMENT OF MEMBERS OF COMMISSION.

The Commission shall consist of ten (10) members who shall be appointed by the Board of Supervisors. The Supervisors of each district shall appoint two (2) members. The two (2) members appointed by the individual Supervisors of Districts 1, 2 and 3 shall serve a term which shall become effective on the date the member is appointed and shall expire on June 30, 1977. The two (2) members appointed by the individual Supervisors of Districts 4 and 5 shall serve a term which shall become effective on the date the member is appointed and shall expire on June 30, 1975. All subsequent appointments shall be for a term of four (4) years and shall expire on June 30 of the fourth year after appointment. Members of the Commission shall serve at the pleasure of the Board of Supervisors. (Ord. 1023 § 3, 4/22/75; amended by Ord. 1444 § 4, 1/13/81)

## 228-5. OFFICERS AND THEIR DUTIES.

The members of the Commission shall select a Chairman, a Vice Chairman and a Secretary. The Chairman shall preside at all meetings and shall
