If the Application is approved, the County is hereby authorized and directed to enter into, execute, and deliver a Program Funding Agreement for the total award amount, and all other documents required or deemed necessary or appropriate to secure the Program grant funds from the Department and to participate in the Program, and all amendments thereto (collectively, "Program Documents").
3.	The County hereby acknowledges and agrees that it shall be subject to the terms and conditions specified in the Program Funding Agreement. Any and all activities, expenditures, information, and timelines represented in the Application are enforceable through the Program Funding Agreement. Funds are to be used for the allowable expenditures and activities identified in the Program Funding Agreement.
4.	The Humboldt County Department of Health and Human Services Director, or a designee thereof, is hereby authorized to execute the Application and the Program Documents on behalf of the County for participation in the Program.
