96.6, AND 431-109 RELATING TO PARKING ON HARRIS STREET, PARK STREET, SCENIC DRIVE, AND WALNUT STREET, AND AMENDING SECTION

435-3 REGARDING ESTABLISHMENT OF CLASS II BICYCLE LANES IN

MCKINLEYVILLE AND EUREKA TO TITLE IV OF THE HUMBOLDT COUNTY

CODE

RECOMMENDATION(S): That the Board of Supervisors:

- 1. Introduce the attached Ordinance by title and waive the first reading;
- 2. Set the Ordinance for adoption on February 24, 2015 or at least one week from that date;
- 3. Direct the Clerk of the Board to publish the pre-adoption summary of the Ordinance and to post a certified copy of the full text of the proposed Ordinance in the office of the Clerk of the Board, both the publication and posting to be done at least five (5) days prior to the Board meeting at which the Ordinance will be adopted. [Government Code Section 25124 (b)(1)];
- 4. Direct the Clerk of the Board, within 15 days after adoption of the Ordinance, to publish a post-adoption summary of the ordinance with the names of the Supervisors voting for and against the Ordinance, and to post in the office of the Clerk of the Board a certified copy of the full text of the adopted Ordinance and amendments along with the names of those

DISCUSSION:

The proposed ordinance prohibits parking along a portion of Harris Street, Park Street, and Walnut Street in Eureka, restricts parking on a portion of Scenic Drive in Trinidad, and includes additional bicycle lanes in McKinleyville and Eureka. (See Attachment 1)

The proposed no-parking zone on the south side of Harris Street (between Post Mile 0.871 to Post Mile 0.887) was requested by Humboldt County Department of Public Works Engineering Division to comply with the Humboldt Transit Authority Bus Shelter Project. (See Attachment 2)

The proposed no-parking zone on the south side of Park Street (between Post Mile 0.000 to Post Mile 0.048) was requested by Humboldt County Department of Public Works Engineering Division to comply with the Humboldt Transit Authority Bus Shelter Project and because the roadway narrows in this area, to comply with the new class II bicycle lane. (See Attachment 2)

The proposed no-parking zone on the northwest side of Walnut Street (between Post Mile 0.871 to Post Mile 0.887) was requested by the Cutten School and the Safe Routes to School Committed Taskforce to comply to the recommendations of the "Walkability Audit and Workshop Outcomes Winship Middle School and Cutten Elementary School," April 16, 2013. (See Attachment 3)

The proposed limited parking from 10:00 p.m. to 5:00 a.m. on Scenic Drive (between Post Mile 2.313 to Post Mile 2.343) was requested by the Trinidad Rancheria, to prohibit overnight parking. (See Attachment 4)

The additional established Class II Bicycle Lanes on School Road in McKinleyville, and Park Street in Eureka are recently completed projects and need only to be codified.

The proposed ordinance revision is considered a project under the California Environmental Quality Act (CEQA). This project is categorically exempt from environmental review pursuant to Section 15301 (Existing Facilities) and Section 15305 (Minor Alterations in Land Use Limitations) of the CEQA Guidelines, and the application of this categorical exemption is not barred by one of the exceptions set forth in Section 15300.2 of the CEQA Guidelines. A Notice of Exemption is included in Attachment 5.

FINANCIAL IMPACT:

The cost for the manufacturing and installation of the regulatory signs are estimated at \$130.00 per sign and is covered in the Road Fund budget. There will be no impact to the General Fund.

The requested action conforms to the Board of Supervisors core roles of providing for and maintaining infrastructure and creating opportunities for improved safety.

OTHER AGENCY INVOLVEMENT:

California Highway Patrol, which enforces traffic laws on County roads

ALTERNATIVES TO STAFF RECOMMENDATIONS:

Not adopt the ordinance; however, this action would not improve traffic safety in these locations.

431-92. PARKING ON RAILROAD AVENUE.

- (a) The parking of vehicles is hereby prohibited at all times on the following portions of Railroad Avenue (County Road No. C3J740):
- (1) The north side thereof from the Northwestern Pacific Railroad tracks to Humboldt Bay.
- (2) The south side thereof from the east end of the boat ramp to a point 200 feet (60.96 meters) easterly thereof. (Ord. 432, § 1, 5/8/62)
- (b) Angle parking shall be permitted on the south side of Railroad Avenue (County Road No. C3J740) from a point 200 feet (60.96 meters) west of the Northwestern Pacific Railroad tracks to a point 200 feet (60.96 meters) east end of the boat ramp. 



Overview: A Walkability Audit and Workshop was held in Cutten on April 16, 2013 to observe and identify concerns and solutions to safety issues around kids who walk or bike to Cutten Elementary School and for those who will be walking or bicycling to Winship Middle School when it re-opens in fall of 2013. Parents, neighbors, the school principals, the California Highway Patrol, the Eureka Police Department's School Resource Officer, Humboldt County Public Works Department, Humboldt County Office of Education's (HCOE) California Joint Powers Authority Risk Manager, HCOE's bus transportation manager, NRS/RCAA staff, and County Public Health were all on hand to witness firsthand the challenges and opportunities around safe walking and bicycling in Cutten. The Audit was supported by the County-wide Safe Routes to Schools (SR2S) Task Force and funded through the Redwood Crossing Guard Program, a Safe Routes to Schools non-infrastructure grant received by Humboldt County Public Works and administered by the Humboldt County Department of Health and Human Services.

Cutten Elementary Engineering/Infrastructure Recommendations:

- Install 3-way stop at Walnut and Cypress
- Shorten crossing distance at Walnut and Cypress by installing bulbouts
- Install LED lights in pavement at crosswalks
- Move flashing School Zone Light closer to the school
- · Install clear directional signage in drop-off and pick-up zone
- Consider re-routing cars on track to exit through parking lot vs. Foxwood Drive
- Trim foliage at Primrose and Walnut to improve visibility
- Consider installing raised crosswalk with bulbouts on Walnut across from Cutten Elementary
- Paint red curb on both ends of Walnut crosswalk (at Primrose) to improve visibility
- Paint red curb next to fire hydrant at end of Primrose crosswalk
- · Create No Parking Zone by painting red curb on Walnut across from Cutten Elementary

Cutten Elementary Parent/Staff Education Needs:

- · Train teachers to hold kids at gate until safe to move towards cars
- Spearhead effort for PTA to partner with Winship PTA/PTO
- · Include pick-up and drop-off guidelines in school newsletter
- Create hand painted signs to encourage drivers to slow and/or for directional signs
- Educate/remind parents to yield to drivers on Foxwood Drive
- Purchase lighted stop paddles for crossing guard
- Educate parents to not U-Turn on Primrose
