**RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS  
AUTHORIZING ACCEPTANCE OF GRANT FUNDING MADE AVAILABLE WITH  
FEDERAL FUNDS UNDER THE HELP AMERICA VOTE ACT OF 2002 TO ASSIST  
THE COUNTY IN COMPLYING WITH THE REQUIREMENTS OF SECTION 301 OF  
THE HELP AMERICA VOTE ACT OF 2002; AND AUTHORIZING THE CLERK,  
RECORDER, AND REGISTRAR OF VOTERS TO EXECUTE NECESSARY  
DOCUMENTS AND CONTRACTS.**

**WHEREAS**, the Help America Vote Act of 2002 (HAVA) requires that each voting system used in a federal election on or after January 1, 2006, must meet all of the requirements of Section 301(a) of the Help America Vote Act; and


**WHEREAS**, the purpose of HAVA funding in the amount of \$162,722.68 is to assist the county in, or reimburse the county for complying with the requirements of Section 301 of HAVA under the terms and conditions set forth in Standard Agreement, No. Agreement No. 21G30106; and

**WHEREAS**, the Humboldt County Office of Elections may use these funds for voting equipment for voters with disabilities, the cost of voter education with respect to use of the voting systems, cost of election worker training with respect to use of the voting system, cost of vote by mail system equipment upgrades, and to meet the requirements of alternative language access pursuant to the Voting Rights Act of 1965.

**NOW, THEREFORE, THE HUMBOLDT COUNTY BOARD OF SUPERVISORS  
HEREBY RESOLVES AS FOLLOWS:**

1. The County of Humboldt is authorized to receive the sum of \$162,722.68 through HAVA.
2. The Board of Supervisors directs the Auditor-Controller's Office to create a supplemental budget in the amount of \$162,722.68 to revenue line 519101 and expenditure line 2123.
3. The Board of Supervisors authorizes Kelly E. Sanders, Clerk, Recorder & Registrar of Voters of the County of Humboldt, or her designees, to execute the necessary documents and contracts for Standard Agreement, No. 21G30106, with the Secretary of State for the State of California.
