<u>RECOMMENDATION(S)</u>: That the Board of Supervisors approve request for consolidation with the condition that the City of Eureka reimburse the County for costs incurred pursuant to this request, and notify the Elections Department of the County to take any and all steps necessary for the holding of the consolidated election.

<u>DISCUSSION</u>: On June 7, 2016, the Eureka City Council passed Resolutions 2016-28 and 2016-29, calling for consolidation of the General Municipal Election with the Statewide General Election to be held on November 8, 2016 for the purpose of the election of certain officers as required by the provision of the charter. On July 5, 2016 the Eureka City Council passed Resolutions 2016-39, 2016-40, 2016-42 and 2016-43 calling for submission to the voters, a question relating to amendment to the Low Income Housing Unit limit within the City of Eureka and for submission to the voters, a question relating to the Charter of the City of Eureka.

A RESOLUTION OF THE CITY COUNCIL
OF THE CITY OF EUREKA CALLING FOR THE HOLDING OF A GENERAL
MUNICIPAL ELECTION TO BE HELD ON TUESDAY, NOVEMBER 8, 2016, FOR THE
ELECTION OF CERTAIN OFFICERS AS REQUIRED BY THE PROVISIONS OF THE
CHARTER

WHEREAS, under the provisions of the Charter a General Municipal Election shall be held on November 8, 2016, for the election of Municipal Officers; and

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF EUREKA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. That pursuant to the requirements of the Charter, there is called and ordered to be held in the city of Eureka, California, on Tuesday, November 8, 2016 a General Municipal Election for the purpose of electing the following offices for the full term of four years:

Councilmember, Second Ward Councilmember, Fourth Ward

SECTION 2. That the ballots to be used at the election shall be in form and content as required by law.

SECTION 3. That the City Clerk is authorized, instructed and directed to coordinate with the County of Humboldt County Clerk to procure and furnish any and all official ballots, notices, printed matter and all supplies, equipment and paraphernalia that may be necessary in order to properly and lawfully conduct the election.

SECTION 4. That the polls for the election shall be open at seven o'clock a.m. of the day of the election and shall remain open continuously from that time until 8 o'clock p.m. of the day of the election and shall pursuant to Election Code § 10242, except as provided in § 14401 of the Elections Code of the State of California.

SECTION 5. That in all particulars not recited in this resolution, the election shall be held and conducted as provided by law for holding municipal elections.

SECTION 6. That notice of the time and place of holding the election is given and the City Clerk is authorized, instructed and directed to give further or additional notice of the election, in time, form and manner as required by law.

SECTION 7. That the City Clerk shall certify to the passage and adoption of this Resolution and enter it into the book of original Resolutions.

Exhibit A

SECTION 201. WARDS.

The City is hereby divided into five (5) wards, numbered consecutively from one (1) to five (5), inclusive, the respective boundaries of which shall be as established on the effective date of this section; provided, that the Council shall by ordinance change such boundaries from time to time to provide equal representation among the five (5) wards in compliance with the one person – one vote principle. The qualified electors of the City voting as a whole shall elect one member of the Council from each of the five (5) wards of the City the ward in which the residents are registered to vote.
