RESOLUTION OF THE COUNTY OF HUMBOLDT BOARD OF SUPERVISORS AUTHORIZING AN EXCEPTION TO THE ONE HUNDRED EIGHTY (180) DAY WAIT PERIOD OF THE CALIFORNIA PUBLIC EMPLOYEES RETIREMENT SYSTEM PURSUANT TO CALIFORNIA GOVERNMENT CODE SECTIONS 7522.56 AND 21224

WHEREAS, in compliance with Government Code section 7522.56, the Humboldt County Board of Supervisors must provide this certified resolution to the California Public Employees Retirement System (CalPERS) when hiring a retiree before one hundred eighty (180) days has passed since their retirement date; and

WHEREAS, Judith Hedgpeth (employee ID# H1723) has retired from the Humboldt County Office of Elections as an Elections Manager effective April 1, 2022; and

WHEREAS, Government Code section 7522.56 requires that Ms. Hedgpeth's post-retirement employment commence no earlier than one hundred eighty (180) days after the retirement day, which is September 28, 2022, without this certified resolution; and

WHEREAS, Government Code section 7522.56 provides that this exception to the one hundred eighty (180) day wait period shall not apply if the retiree accepts any retirement-related incentive upon retirement; and

WHEREAS, the Humboldt County Board of Supervisors, the Humboldt County Office of Elections, and Ms. Hedgpeth certify that Ms. Hedgpeth has not and will not receive a Golden Handshake or any other retirement related incentive; and

WHEREAS, Ms. Hedgpeth's employment shall be limited to 960 hours per fiscal year; and

WHEREAS, the Humboldt County Board of Supervisors hereby appoints Ms. Hedgpeth as an extra help retired annuitant to perform the duties of an Administrative Analyst II for the Office of Elections under Government Code Section 21224, effective April 25, 2022; and

WHEREAS, the entire employment agreement, contract, or appointment document between Ms. Hedgpeth and the Office of Elections has been reviewed by this body and is included herein; and

WHEREAS, no matters, issues, terms, or conditions related to this employment and appointment have been or will be placed on consent calendar; and

WHEREAS, Ms. Hedgpeth's compensation paid cannot be less than the minimum nor exceed the maximum monthly base salary paid other employees performing comparable duties, divided by 173.333 to equal the hourly rate; and

WHEREAS, the maximum base salary for this position is \$5,874.55 per month and the hourly equivalent is \$33.89. The minimum base salary for this position is \$4,579.46 per month and the hourly equivalent is \$26.42.

WHEREAS, the hourly rate paid to Ms. Hedgpeth will be thirty-three dollars and ninety cents (\$33.90).

Two full time positions in the Office of Elections are currently vacant. This appointment will allow uninterrupted operation and service.
