RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS AUTHORIZING HUMBOLDT COUNTY DIRECTOR OF AVIATION OR DESIGNEE THEREOF TO EXECUTE ANY AND ALL DOCUMENTS RELATED TO THE CARES ACT GRANT

WHEREAS, the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) was passed by Congress and signed into law by President Trump on March 27th, 2020. Title XII of Division B of the CARES Act provides approximately \$10 billion to support U.S. Airports experiencing severe economic disruption caused by the COVID-19 public health emergency. This funding will be distributed to airports to prevent, prepare for, and respond to the impacts of the COVID-19 public health emergency.

WHEREAS, these funds are available only to sponsors as defined in section 47102 of title 49, United States Code (U.S.C); that is, airport sponsors meeting statutory and policy requirements under this section and identified in the FAA's current National Plan of Integrated Airport Systems (NPIAS); and

WHEREAS, the County of Humboldt ("County"), by and through the Federal Aviation Administration (FAA) has allocated to Humboldt County Department of Aviation funding that has been made available through the CARES Act.

NOW, THEREFORE, THE HUMBOLDT COUNTY BOARD OF SUPERVISORS HEREBY RESOLVES AS FOLLOWS:

1. The Humboldt County Director of Aviation, or a designee thereof, is hereby authorized to conduct any and all negotiations, and enter into, execute and deliver any and all documents, including, without limitation, agreements, amendments and payment requests, required, or deemed necessary, to accept and secure an allocation of funding made available through the CARES Act.
2. If the Humboldt County Director of Aviation, or a designee thereof, agrees to accept funding made available through the CARES Act, the County hereby represents and certifies that the County will only utilize these funds for any purpose for which airport revenues may be lawfully used pursuant to the FAA's Policy and Procedures Concerning the Use of Airport Revenues.


