

RESOLUTION NO. 26-88

A RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS ADOPTING A POLICY FOR ADDRESSING TECHNICAL DISRUPTIONS DURING PUBLIC MEETINGS

WHEREAS, the Humboldt County Board of Supervisors conducts public meetings in accordance with the requirements of the Ralph M. Brown Act to ensure transparency, accountability and meaningful public participation in local government; and

WHEREAS, California State Senate Bill 707 requires legislative bodies that are required to provide remote participation during public meetings to address technical disruptions that prevent the public from remotely accessing such meetings; and

WHEREAS, the County of Humboldt seeks to ensure that members of the public are provided reliable opportunities to observe and participate in meetings, including through a two-way telephonic service or a two-way audiovisual platform as required by California Government Code Section 54953.4; and

WHEREAS, technical disruptions may occur due to loss of internet connectivity, telephone service, electrical power outages and equipment failures, which may prevent members of the public from accessing public meetings remotely; and

WHEREAS, the County of Humboldt desires to establish clear procedures for addressing such disruptions in order to maintain compliance with applicable law while allowing the orderly continuation of County business when appropriate.

NOW, THEREFORE, BE IT RESOLVED that the Humboldt County Board of Supervisors hereby adopts the Humboldt County Technical Disruption Policy, Policy No. BOS-26-01, governing technical disruptions during public meetings.
