RESOLUTION OF THE HUMBOLDT COUNTY BOARD OF SUPERVISORS APPROVING THE MEMORANDUM OF UNDERSTANDING FOR AMERICAN FEDERATION OF STATE, COUNTY & MUNICIPAL EMPLOYEES, AFL-CIO LOCAL 1684 REPRESENTATION UNITS 1 - 4, ADOPTING A COMPREHENSIVE SCHEDULE AND CLASSIFICATION SUMMARY, AND DELEGATING AUTHORITY TO THE DEPARTMENT OF HUMAN RESOURCES TO REFLECT FUTURE CHANGES

WHEREAS, the Board of Supervisors of the County of Humboldt (County) is authorized by the provisions of Section 25300 of the Government Code of the State of California to provide for the number, compensation, tenure, appointment and conditions of employment of County employees by resolution; and

WHEREAS, on August 21, 2018, the Board of Supervisors adopted Resolution No. 18-81, providing for the implementation of the 2017-2020 Memorandum of Understanding for the American Federation of State, County & Municipal Employees, Local 1684 Representation Units 1 – 4 and on April 6, 2021, the Board of Supervisors executed a side letter of agreement providing for the implementation of the extension of Memorandum of Understanding for the American Federation of State, County & Municipal Employees, Local 1684 Representation Units 1 - 4; and


WHEREAS, the Board of Supervisors desires to adopt a new resolution approving and providing for the implementation of the 2022 - 2024 Memorandum of Understanding for the American Federation of State, County & Municipal Employees, AFL-CIO Local 1684 Representation Units 1 - 4; and

WHEREAS, California Employees Retirement System (CalPERS) requires all government agencies to provide and make available to the public the salary of all full-time, part-time employees and Elected Officials in a single salary format specified by CalPERS.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS:

1. The attached Memorandum of Understanding (Attachment No. 1 of the report this date) for the term of 2022-2024 for the Memorandum of Understanding between the County of Humboldt and the American Federation of State, County & Municipal Employees, AFL-CIO Local 1684 Representation Units 1 - 4 is hereby adopted.
2. The Board of Supervisors adopts a Comprehensive Compensation Schedule and Classification Summary (Attachment No. 5 of the report this date) effective January 9, 2022.
3. Authority is delegated to the Department of Human Resources to update the Comprehensive Compensation Salary and Classification Summary to reflect changes in future compensation approved by your Board.
