Hi Devin.

Thank you for sharing the botanical report. It looks like there aren't rare plants or sensitive natural communities, which is consistent with my observations from an earlier site visit. My only recommendation at this point would be to include a condition of approval to protect migratory birds, since the applicant is planning to remove two Monterey cypress. CDFW strongly recommends that it be done outside of the nesting bird season (generally March 15 – August 15). Alternatively, although discouraged due to the potential for project delays and associated costs, a qualified biologist shall survey for active bird nests no more than seven days prior to the start of any project-related activities with the potential to impact nesting birds. If an active nest is found, the permittee should consult with CDFW regarding appropriate site-specific avoidance measures and buffer distances. If there is a lapse in project-related activities of seven days or more, the biologist should re-survey the area before work resumes.
