WHEREAS, this fundamental right was guaranteed by our nation's founders in the First Amendment to the Constitution; and

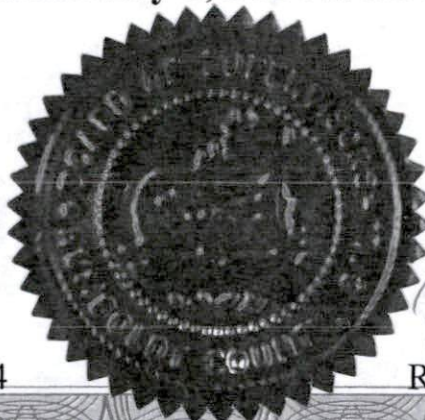
