

**FIRST AMENDMENT TO LEASE AGREEMENT**

This First Amendment to Lease Agreement entered into on this 25<sup>th</sup> day of January 2022, between the COUNTY OF HUMBOLDT, a political subdivision of the State of California, hereinafter referred to as COUNTY, and Elaine Joyce Foote Revocable Trust, hereinafter referred to as LESSOR;

**WHEREAS**, the parties entered into a Lease on August 11, 2020 for the use of the premises at located at 404 H Street, Eureka, County of Humboldt, State of California for use purpose of office space for County programs managed by the Probation Department; and

**WHEREAS**, the parties entered into a Lease for the use of the premises at 404 H Street, Eureka, for the purpose of offices for County programs managed by the Probation Department;

**WHEREAS**, COUNTY and LESSOR desire to modify the Lease as specified; and

**NOW, THEREFORE**, it is mutually agreed as follows:

1. Section 10. JANITORIAL of this Lease shall be amended to add the following provisions:

COUNTY shall reimburse LESSOR a monthly fee of Nine Hundred Twenty Eight Dollars (\$928.00) for the janitorial costs as defined and described in Exhibit B.— Cleaning Checklist, effective on March 1, 2022

COUNTY shall reimburse LESSOR for the Janitorial fee increases with a one-time payment totaling One Hundred Thirty Two Dollars (\$132), the amount of which is calculated as being a monthly increase of Forty Four Dollars (\$44) per month for the months of Dec. 2021, Jan. 2022, and Feb. 2022.

2. Section 28. NOTICE of this Lease shall be amended to read as follows for LESSOR:

In all other respects, the Lease between the parties entered into on August 11, 2020 shall remain in full force and effect.
