DISCUSSION:

In November 1998 the Board approved Resolution 98-86, as authorized by Statute 587 Section 1 of California Vehicle Code Section 9250.19, to collect separate vehicle registration fee surcharges to enhance the capacity of local law enforcement to provide automated fingerprint identification locations. In Humboldt County the Sheriff's Office administers the collection of the increased vehicle registration fingerprint identification fees and provides equipment and support for the following Livescan fingerprinting locations. The Remote Access Network (RAN) Board was established to provide oversight of the funds collected and administered by the County.

On November 18, 2015 the RAN Executive Committee approved a total distribution of \$615,000 to participating agencies. Funds collected under California Vehicle Code Section 9250.19 must be used for personnel or equipment related to crimes associated with driving under the influence, vehicular manslaughter or other motor vehicle-related crimes. The purchase of a 3-D scanner camera will enable the Sheriff's Office to perform crime scene documentation and reconstructions. There are currently no other cameras of this type in Humboldt County and this purchase will enhance the capabilities of all RAN participating agencies.

A supplemental budget in the amount of \$68,000 is requested to transfer revenue to budget unit 221 and to establish a fixed asset expense line to record equipment costs. All costs for the 3-D scanner camera will be covered by the RAN fund distribution.

FINANCIAL IMPACT:

A supplemental budget adjustment in the amount of \$68,000 is requested to establish a line item in the approved FY2015-16 budget for the Humboldt County Sheriff's Operations budget unit 221 under Fixed Asset – Camera (1100-243-8615). The supplemental budget adjustment is requested for the purchase of a new 3-D Scanner Camera and related software.

Funds to cover the cost of the camera will be transferred from RAN Trust 3495 to revenue line 1100-221-707520. The current balance of Trust 3495 is \$715,762 and the Sheriff's Office share is \$348,447. The remaining balance after all distributions have been paid will be \$100,762. The RAN fund earns approximately \$135,000 each year, with expenses of approximately \$70,000 for the maintenance of livescan equipment throughout the County. No contribution from the General Fund is required.

The budget adjustment meets the Board of Supervisors Strategic Framework Plan goal of providing community-appropriate levels of service by investing in infrastructure to benefit the community.

ALTERNATIVES TO STAFF RECOMMENDATIONS:

The Board could deny the request to approve the budget supplemental adjustment request, however, this is not recommended as the purchase of the Full-Body Security Scanning System will significantly improve safety in the booking area of the Correctional Facility.
