A RESOLUTION AUTHORIZING THE HUMBOLDT COUNTY HEALTH OFFICER AND THE DEPARTMENT OF HEALTH AND HUMAN SERVICES – PUBLIC HEALTH, DIVISION OF ENVIRONMENTAL HEALTH, TO SERVE AS THE ENFORCEMENT AGENCY FOR STATE LAW REQUIREMENTS RELATING TO SINGLE-USE FOODWARE ACCESSORIES AND CONDIMENTS

RESOLUTION NO. 22-65

WHEREAS, California Governor Gavin Newsom signed into law Assembly Bill 1276 regarding "Single-use Foodware Accessories and Standard Condiments" on October 5, 2021;

WHEREAS, Assembly Bill 1276, as codified in Chapter 5.2 of Part 3 of Division 30 of the Public Resources Code, aims to reduce waste associated with plastics and non-reusable foodware by prohibiting food facilities from providing any single-use foodware accessory or standard condiment packaged for single use to a customer unless requested by the customer;

WHEREAS, Public Resources Code section 42272 requires a city, county, or city and county to identify and authorize an enforcement agency on or before June 1, 2022;

WHEREAS, the Humboldt County Health Officer and the Department of Health and Human Services – Public Health, Division of Environmental Health, has the requisite expertise, knowledge, and skill to serve as the County's enforcement agency for purposes of this new legislation; and

WHEREAS, the Humboldt County Health Officer and the Department of Health and Human Services – Public Health, Division of Environmental Health, routinely inspects food facilities and generators within the unincorporated areas of Humboldt County and on behalf of other local jurisdictions;

NOW THEREFORE BE IT RESOLVED that the Humboldt County Board of Supervisors hereby:

- 1. Authorizes and appoints the Health Officer and the Department of Health and Human Services Public Health, Division of Environmental Health, as the enforcement agency for the requirements of Assembly Bill 1276 and Public Resources Code section 42272 in the unincorporated areas of Humboldt County; and
- 2. Authorizes the Health Officer and the Department of Health and Human Services Public Health, Division of Environmental Health, to issue Notices of Violation, levy and collect fines within the limits of the law.
