**RESOLUTION TO SUMMARILY VACATE A PORTION OF THE PUBLIC UTILITY EASEMENT ADJACENT TO KRISTEN WAY (4L851) IN MCKINLEYVILLE**

**WHEREAS**, a California Streets and Highways Code Section 8333 allows the legislative body of a County to summarily vacate a public service easement when such easement been superseded by relocation, or determined to be excess by the easement holder, and there are no other public facilities located within the easement; and

**WHEREAS**, a public utility easement is considered a public service easement; and

**WHEREAS**, a twenty-five (25) foot public utility easement, shown as Parcel "J", was established on Tract No. 388, filed in Book 20 of Maps, pages 96-98, in the Office of the Humboldt County Recorder; and

**WHEREAS**, Parcel "J" is more particularly described on said Tract No. 388 as "Parcel J (25-foot-wide access and utility easement), as shown hereon, is a non-exclusive easement for ingress, egress, and for public utilities created by this map".

**WHEREAS**, that portion of Parcel "J" proposed for summary vacation as described in Exhibit "A" (legal description) and shown on Exhibit "B" (plat), both of which are attached hereto and made a part hereof by reference, has been determined to be excess; and

**WHEREAS**, Parcel "L", an existing public utility easement, overlaps a portion of Parcel "J" adjacent to Kristen Way; and

**WHEREAS**, Parcel "L" is to remain intact and no portion is proposed to be vacated; and

**WHEREAS**, that portion of Parcel "J" proposed for summary vacation does not contain any public utility infrastructure; and

**WHEREAS**, that portion of Parcel "J" proposed for summary vacation is not needed by public utility providers; and

**WHEREAS**, this summary vacation is made pursuant to the provisions of Chapter 4 of Part 3 of Division 9 of the Streets and Highways Code, and specifically Section 8333(c); and

**WHEREAS**, the Planning and Building Department has found the proposed vacation does not conflict with the requirements of the subdivision map and is in conformance with the General Plan; and

**WHEREAS**, the summary vacation will have no significant environmental effect and is exempt from the California Environmental Quality Act (CEQA) as per the provisions in the Guidelines for Implementation of CEQA (California Code of Regulations, Title 14, Division 6, Chapter 3, Section 15305);

**NOW, THEREFORE, BE IT RESOLVED** that the County of Humboldt Board of Supervisors:

1. Finds that all of the recitations contained hereinabove are true and correct.
2. The summary vacation of that portion of Parcel "J" as described in Exhibit "A" (legal description) and shown on Exhibit "B" (plat) has been determined to be excess by the Department of Public Works.
3. There are no public utilities in the area proposed for summary vacation.
4. The summary vacation does not vacate any portion of Parcel "L".
5. No public utility provider needs any portion of the area proposed for summary vacation.
6. The summary vacation is made pursuant to the provisions of Section 8333(c) of the California Streets and Highways Code.
7. The Planning and Building Department has found the proposed vacation does not conflict with the requirements of the subdivision map and is in conformance with the General Plan.
8. The summary vacation does not have a significant environmental effect and is exempt from CEQA as per the provisions in the Guidelines for Implementation of CEQA, California Code of Regulations, Title 14, Division 6, Chapter 3, Section 15305.
9. Said portion of public utility easement is hereby ordered vacated.
10. From and after the date of recordation of this resolution, said public utility easement as described in Exhibit "A" (legal description) and shown on Exhibit "B" (plat), will no longer constitute a public utility easement.
11. Direct the Clerk of the Board to record in the office of the Humboldt County Recorder, a certified copy of the Resolution via the Land Use Division.

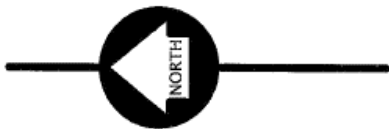
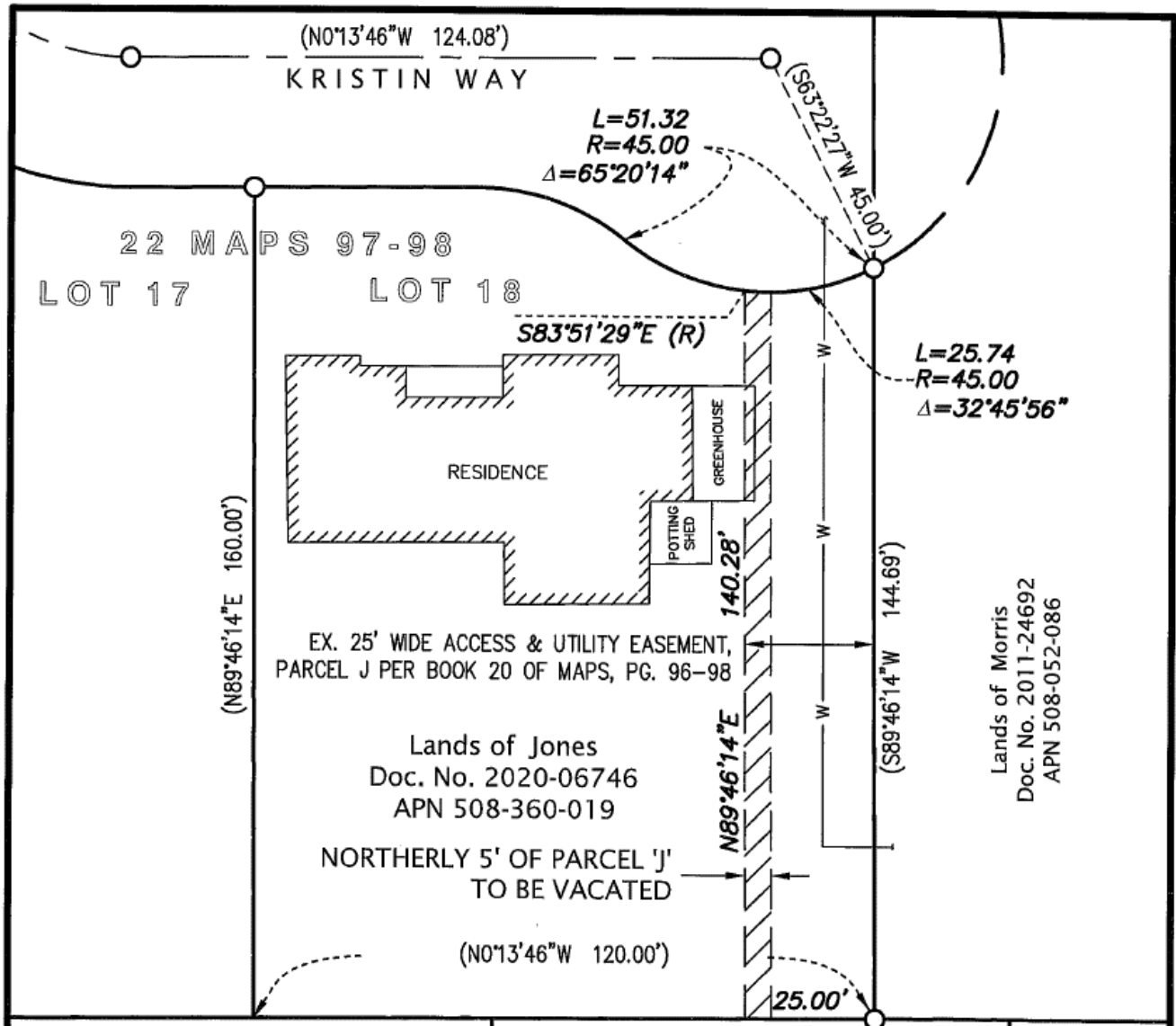
