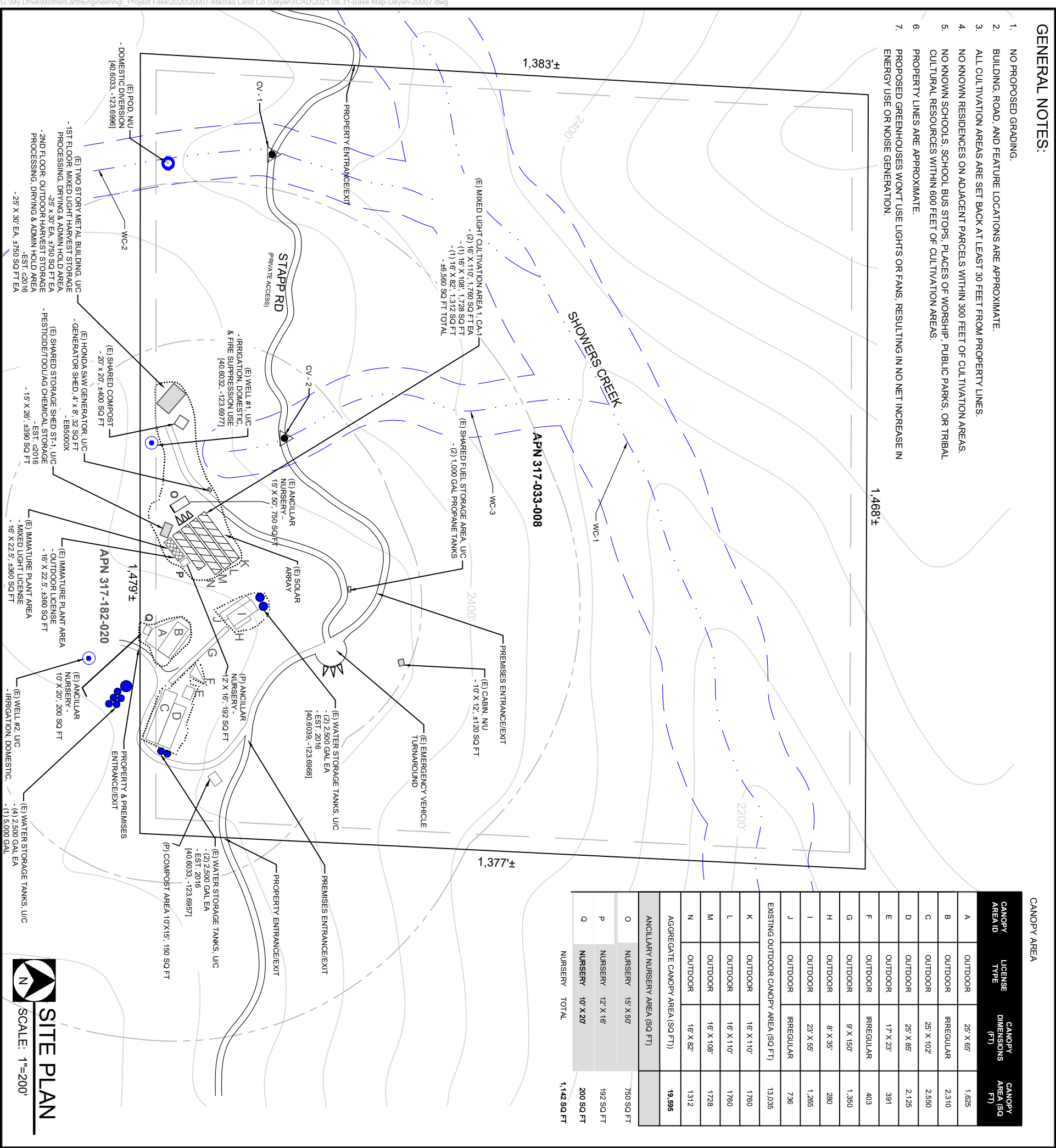

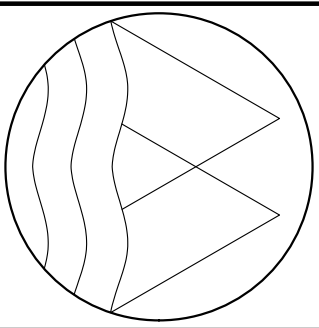
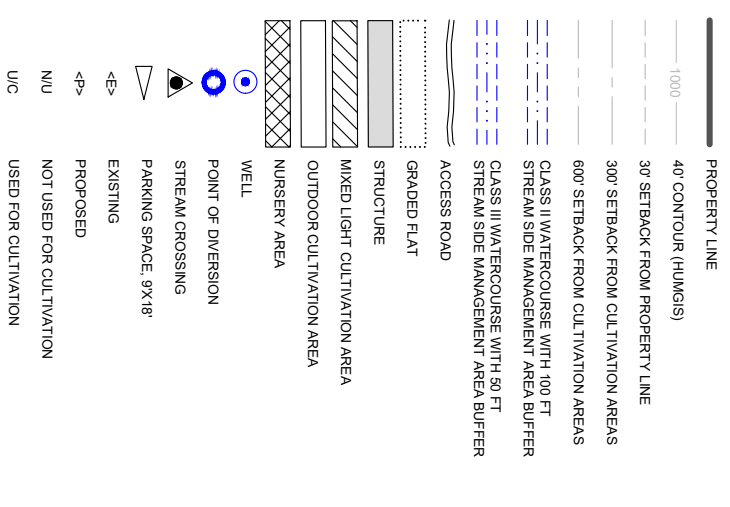
**SITE PLAN**

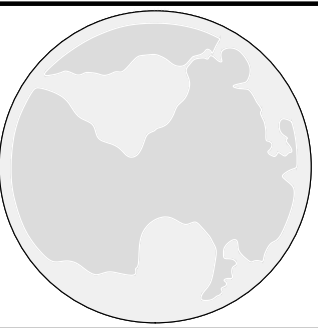

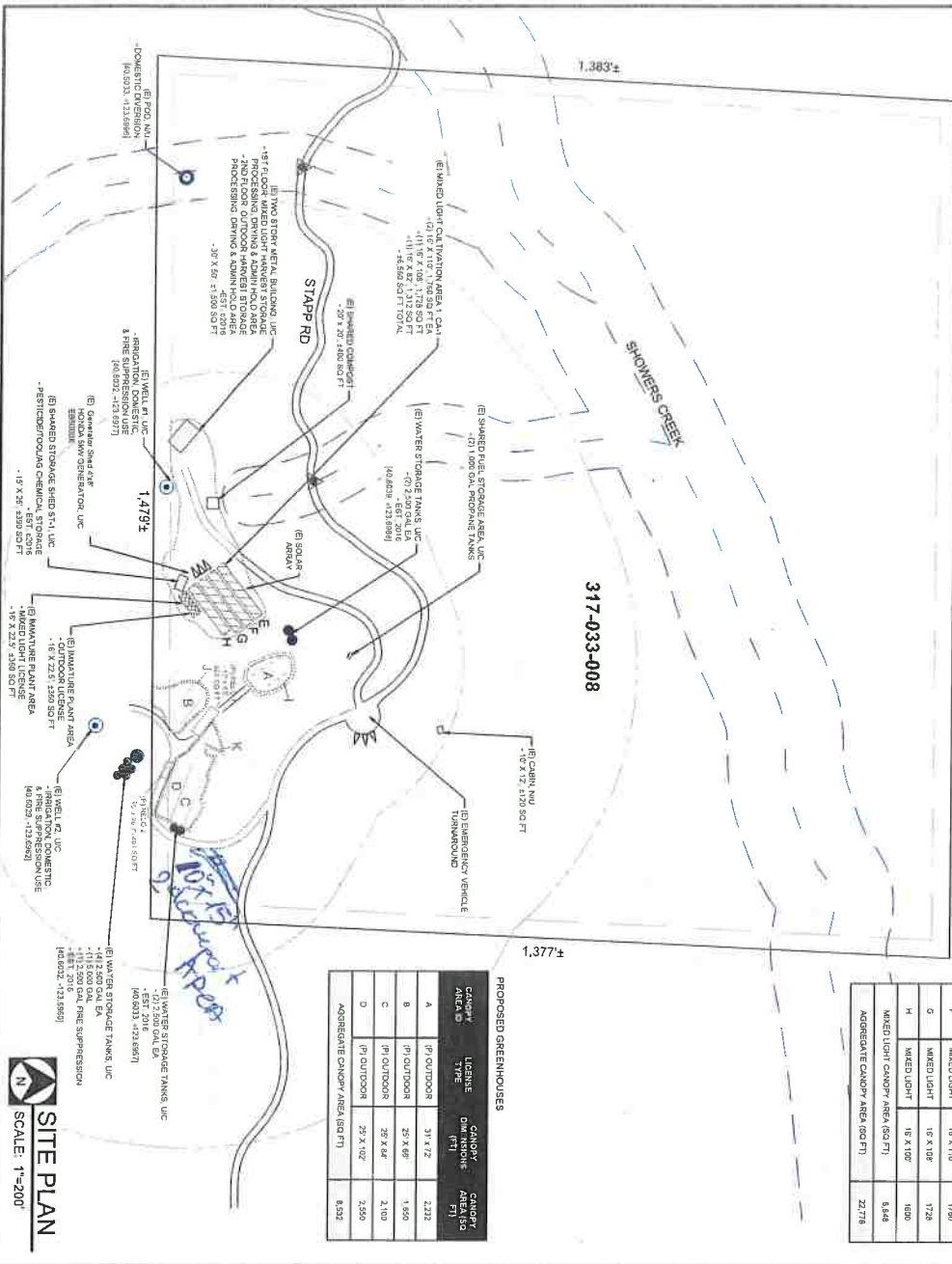

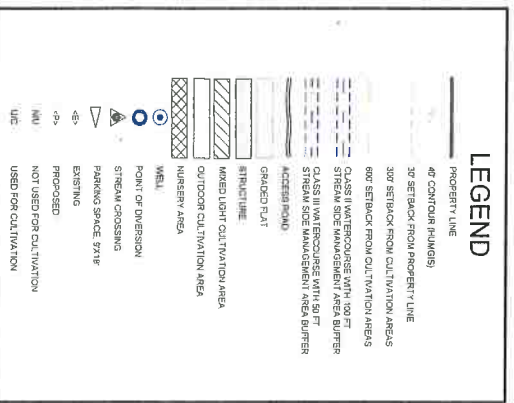
